Marie Conway intends to apply for Planning Permission for development at this site: 18 St. Mary's Avenue, Rathfarnham, Dublin 14, D14X7P8. The development will consist of the erection of a single storey extension to the side of the house with a flat roof, sloped parapet wall and new rooflights. It will include the demolition of a single storey extension to the rear of the house and partial demolition of the boundary wall. The development will also include new glazed patio doors to the rear courtyard garden, the addition of a new rooflight to the rear of the existing roof, the addition of a new retractable bollard to the driveway, and all associated site works and services.
