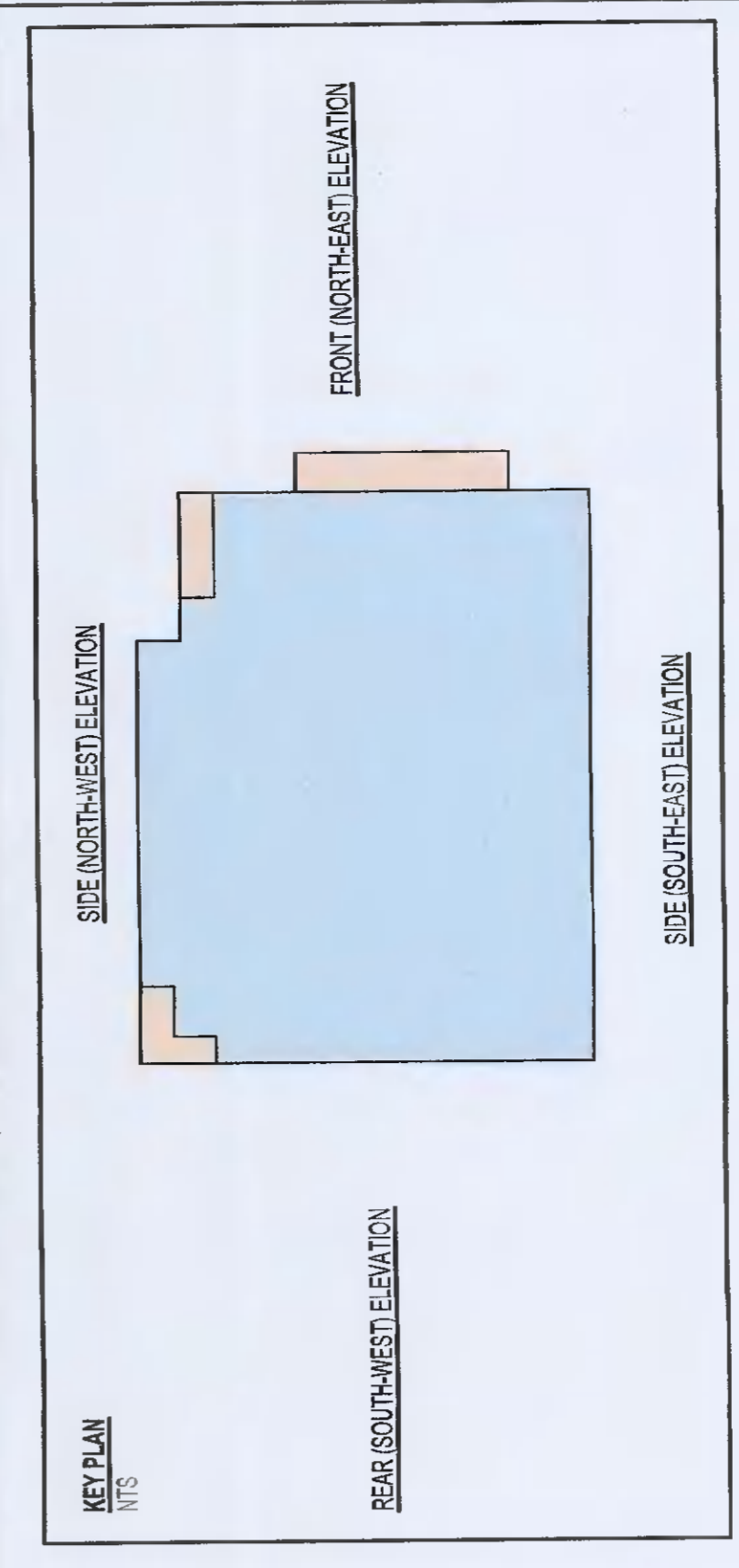

MON. FINE WALL

1. 15mm RHP ANGIKSPAN COARSE GREY RAL 9010 OR EQUIVALENT CLADDING TYPE LAD ON SIDE WALLS.
2. 15mm RHP ANGIKSPAN GREY WHITE OR EQUIVALENT CLADDING TYPE LAD ON 10mm TOPHATS ON SIDE WALLS.

NOTE: STEP OF 60mm IS CREATED BETWEEN CLADDING TYPES 1 & 2 FOR THE ENHANCED ELEVATION APPEARANCE.

FINE WALL

1. 15mm RHP ANGIKSPAN COARSE GREY RAL 9010 OR EQUIVALENT CLADDING TYPE LAD ON FIRE RATED SIDE WALLS.
2. 15mm RHP ANGIKSPAN GREY WHITE OR EQUIVALENT CLADDING TYPE LAD ON 15mm TOPHATS ON FIRE RATED SIDE WALLS.

NOTE: STEP OF 60mm IS CREATED BETWEEN CLADDING TYPES 1 & 2 FOR THE ENHANCED ELEVATION APPEARANCE.
