Objections/ Observations on the proposed development round 2 October 2021

1. I object to the boundary wall being breached and an application for road access being disguised as a cycle /pedestrian way through our estate. Retractable bollards in the planning application are not essential on a cycle path.

And a 5m gap see snap shot below of submitted drawing is wide for a pedestrian way. So if in fact this is really an application for a road way I observe my disquiet on some 200 or so cars extra coming through our estate the reason for this is in breach of the natural and original exit from this land which should be into stocking lane but due to an over development of the land on this road they now want to seriously impact on the every day life of our springvale children's safety and is in breach of the busconnects plan to encourage people to use the new bus corridors which runs in front of and along stocking lane and our Springvale estate is not designed to have this level of increase in traffic. The roads are too narrow and the exit bridge onto edmondstown road is not designed for such an increase in load.

- 2. Along with opening up this wall and it's impact on our estate these cars will be coming out through 3 right angle blind corners within our estate onto a very poor grade road (Edmondstown Rd) which is so narrow and twisty that one has to drive in the cycle lane to drive in many parts. As a cyclist I've frequently had to bump up on the path whose differential in height to the road means cars frequently are forced to do likewise when buses and lorries in the oncoming lane also need to pass a cyclist.
- 3. This small mountain road already has a lot of traffic on it due to the number of cemeteries on it. Presently funerals (in covid) aren't a significant source of traffic but in normal circumstances there would be a significant number passing with large corteges.

4.(as a resident of no 26) We look out from our upper windows and we are still below the level of the boundary wall. on the other side of this boundary the slope rises significantly into the development (see site section c below)

The positioning and height of these buildings will cause significant blockage of light into our houses and gardens.

- 5. House Numbers 22-27 have back walls that are of a Gambian wall structure. I question whether they will continue to support the load and rain water run off that the development of this green field will cause . We have already seen evidence of the drains not holding the flood waters that severe rain falls cause.
- 6. The main busconnects bus routes are on stocking lane thus negating any reason for the development to require any sort of access through springvale estate. With regard to a need for us to access through the new estate We already access this corridor at the Taylors lane roundabout
- 7. Access to the local schools is a shorter walk along stocking lane and the walkways already in place through Boden Park. And our children walk via the front of our own estate.
- 8. There are safer cycle paths already in place on stocking lane (see point made above). Rooting them through our estate on to an inferior road does not make any sense.
- 9. The bus routes in front of our estate run infrequently and the present bus stop is quite a distance from the front of our estate and the bus stop is as easily accessed from the front of the development through their natural exit onto stocking lane
- 9. It is not our problem that the developments previously permitted means that this development has a problem in exiting onto its natural exit. We as a small estate should not have to suffer for this.
- 10. Our estate is a small estate we are already at full capacity with regard to the parking of cars and the width of our roads already have congestion problems requiring bin lorries to reverse up through most of the estate.
- 11. Drainage and sewage are already a problem in Springvale estate. Adding the runoff of another development in top of this already overloaded system will seriously impact us as residents of springvale and would lead to spills into the Owendower river.
