I wish to strongly object to the proposed development on the grounds that any connection with the waste water/ sewage system in Springvale estate would overburden an already problematic system and increase the likelihood of blockages causing raw sewage to discharge into my back garden, as happened on two occasions this summer, necessitating call-outs to private contractors and South Dublin Council. This is an extremely distressing situation and a serious health hazard which I am very fearful would escalate should the proposed development go ahead.

Furthermore, I strongly object to the proposed opening of Springvale Estate to either vehicular or pedestrian access. Any additional traffic would pose a safety risk to young and old. There is a walkway directly outside my house. Allowing an increase in the volume of people using this walkway would lead to more night-time noise and potential anti-social activity. I would also have concerns regarding an escalation of the litter problem as people using the estate as a route would have no vested interest in maintaining the cleanliness of the estate.

I urge you to take these objections into account when considering the application mentioned.
