Dear An Bord Pleanála,

Myself and my wife, Maria Pacini, are strongly opposed to this development. We live in the estate neighbouring this site and have done since 1999. Our local area has already become unrecognisable from when we first moved here. With all the developments in recent years (White Pines North & South on Stocking Avenue, Stocking Wood on Stocking Lane to name a few), it is already suffering from serious road congestion.

This does not factor in what the future addition to traffic will be when current building works such as the huge SHD development on Scholarstown Road are completed with nearly 600 dwellings! Our area is at risk of becoming uninhabitable.

This proposal's only vehicle access is onto Stocking Lane, which is a country lane that is not only congested at rush hour, but increasingly throughout the day and particularly at the weekends. This road also becomes congested when there is an accident on the M50. It is increasingly more difficult to get to work/ school on time every day if traveling by car or bus.
