The seven-year-old gelding only joined Dermot McLoughlin recently and the move seems to have paid dividends as he ran a cracker from 13lb out of the handicap when beating all bar Inflection Point over course and distance at the final meeting before Christmas. Sister Rosetta is also well-in compared with official ratings but is certainly on a downward curve having had a mark of 95 as a juvenile and she needs to bounce back after a disappointing effort here last month. Claimers have proved very fruitful for James McAuley and he's doubly represented by Hightown Heights and Timourid, while Rocky Dreams is another to consider.
