Permission is sought to extend to the rear and side of the existing house to be refurbished including an undercroft lower floor level below the new extension providing access to the lower rear garden. Works to the house will include replacing the existing entrance with a window, a new bay window to the side (southwest) elevation, new vehicle entrance gate, driveway and parking area to the west of the existing house, leading to a new glazed entrance and hall way to the side (existing garden and gates in front of the cottage to be retained). The rear extensions will provide new living/ dining/ kitchen facilities with the extended and refurbished cottage providing room four no. bedrooms. The undercroft level will provide a garden level play room as well as storage areas. Works include for all services on and under land including a new effluent treatment system and new dry stone rubble boundary walls along the existing road.
