I request to put an objection on 2 planning permissions that Lidl has put notice up SD22A/0001 and SD22A/0002. Please note I am the owner of 30 New Seskin court Block C and have been living with the works that are currently going on in Lidl in Whitestown way. Since the works have started my apartment has become unlivable with the sheer volume of noise that is coming from drilling and hammering from the works. I have made numerous complaints to my management company that doesn't seem to stop the noise at all. I need to be able to work from home and take calls while working, I have had to drop numerous calls due to the noise and this has impacted my work hugely, which in turn is impacting my mental health. If I knew the noise would be so bad and so constant, I would have objected to the original planning permission. I have never objected to any planning permission but feel I have no choice now.
