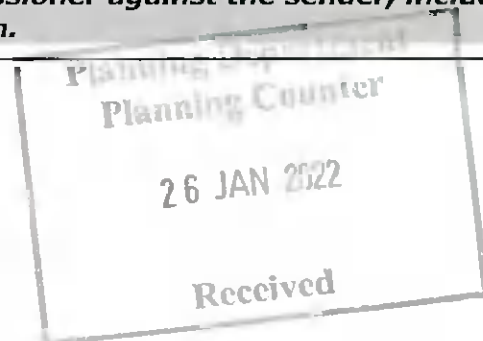

We, Alan & Monica Holmes, intend to apply for permission for development at this site, Paintworld, 1-2 Ballymount Road Lower, Dublin 12.

The proposed development will consist of the demolition of an existing commercial two storey building and the construction of 2 no. commercial units with Plantroom on Ground floor level with 10 no. residential apartments comprising 1 no. Studio apartment, 4 no. 1-Bed apartments and 5 no. 2-bed apartments all with private balconies over 4 floors. A communal roof garden is located on the fourth floor; bin stores for the commercial and residential units is located at the rear of the building, 6 no. car parking spaces is provided for the development. 8 no. bicycle spaces is provided at the front for commercial units and 10 no. bicycle spaces at the rear for the residential units, and all associated engineering and site works necessary to facilitate the development.


