We, Sarah Duke & Philip Tomlinson, intend to apply for permission for development at this site, 36 Kew Park Crescent, Lucan Co Dublin

The development will consist of alterations to previously granted planning permission ref number SD20B/0419. Proposed single storey entrance lobby to the North Elevation with roof light over. Reconfiguration of ground floor kitchen, dining, living area, utility, and office space with introduction of a new fixed roof light over living area to the rear South Elevation. First floor master bedroom, bathroom and walk in wardrobe layout reconfigured. Proposed roof light to southwest of existing main pitched roof re-positioned and overall size increased. Proposed design change to dormer windows located on the Northeast elevation. 2 No feature external planters to ground and first floor level located on the North Elevation. Proposed minor internal alterations to existing dwelling and demolition of existing concrete shed, inclusive of all associated site works.


