Ireland's women pick up Sevens silver in Seville

IRELAND were pipped by Australia in the final of the HSBC World Rugby Sevens in Seville yesterday. In their first-ever appearance in a world series decider, Ireland took a 12-0 lead after tries from Beibhinn Parsons and Stacey Flood. But the Aussies hit back before half-time through Faith Nathan. A Dominique du Toit try had the sides level after the restart before Nathan bagged the winner after Ireland failed to control their own put-in to the scrum. Du Toit broke through the Irish cover and, although she was stopped short of the line, Australia recycled the ball and Nathan went over. Meanwhile, the Irish men's team finished in fourth place after losing their semi-final to South Africa 26-0. They then lost 19-12 to Argentina in the play-off for third place. Ireland's two tries came courtesy of Conor Phillips and Terry Kennedy.
