With reference to your planning application, received on 16-Dec-2021 in connection with the above, I wish to inform you that before the application can be considered under Section 33 of the Planning & Development Act 2000, six copies of the following ADDITIONAL INFORMATION must be submitted.

1. The Planning Authority has concerns regarding the impact of the proposed rear extension, both in term of overbearing impact and over shadowing, on adjoining property located at No. 101 Whitecliff. The applicant is requested to provide a revised roof design for the proposed rear extension, which is no higher than the existing boundary wall with No. 101. A revised design could include a reduction to the eaves height to match the boundary wall or the introduction of a monopitch roof, which falls towards the boundary with No101.

NOTE: The applicant should note that any submission made in repsonse to the above will be examined and MAY be deemed to be SIGNIFICANT ADDITIONAL INFORMATION by the

Planning Authority.
