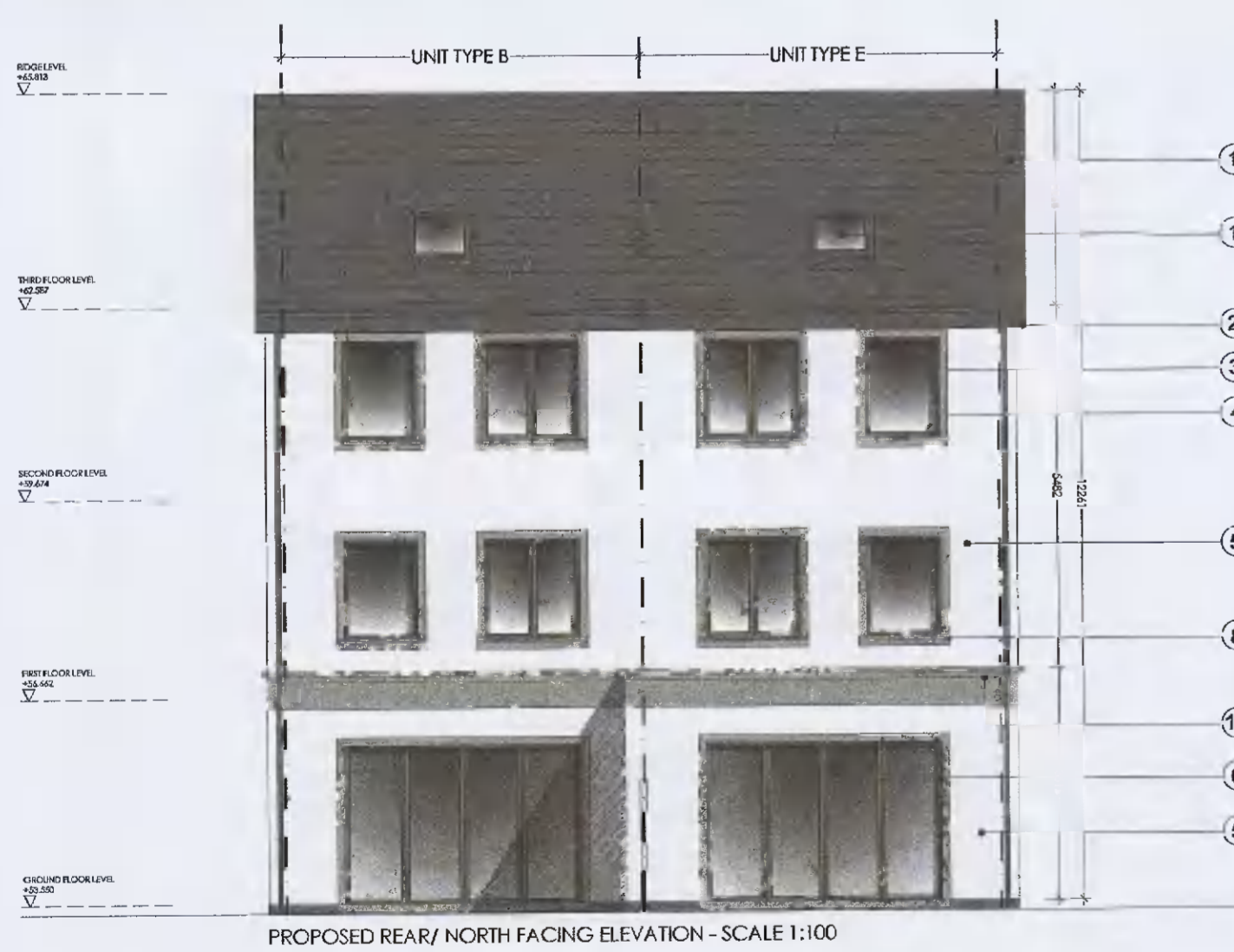
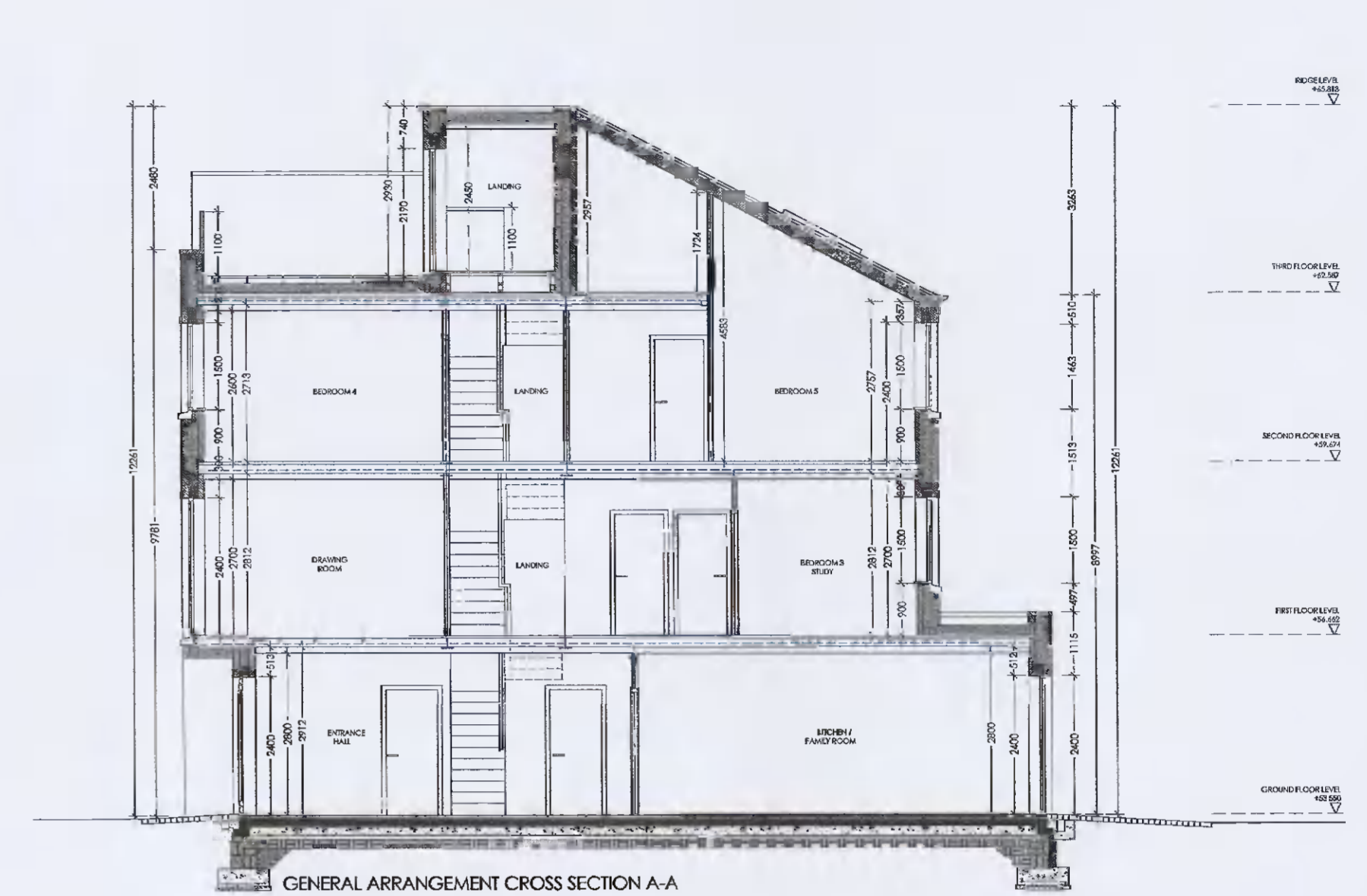
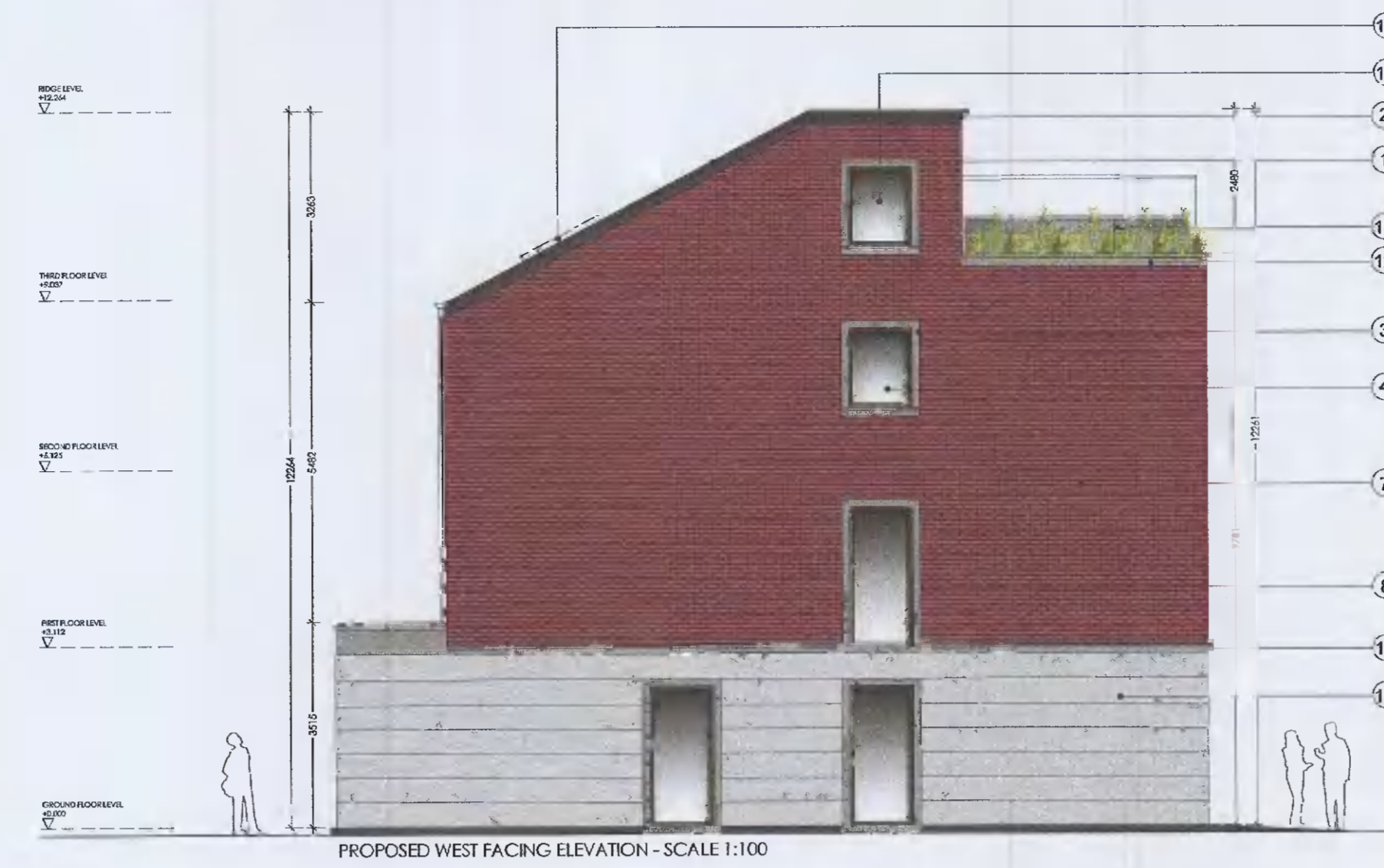


UNIT TYPE E+B - PROPOSED ELEVATIONS & CROSS SECTION SEMI DETACHED UNITS 19 + 20
