We, Aerodrome PropCo Limited, intend to apply for subsequent alterations to previously granted planning alterations application Reg. Ref. SD21A/0083 at Block A, College Lane, Greenogue, Rathcoole, Co. Dublin (note original pl. permission reg.ref. SD18A/0265).

The subject alterations refer to subdivided Unit A2 only and consists of omission of a previously proposed addition to existing staff facilities block A3, which is no longer required as part of the development.

This results in change of use of 133m² ancillary office/staff facilities area on the ground floor to warehouse area, and omission of 174m² ancillary office/staff facilities area on the first floor.

All other details remain as per the granted application Reg. Ref SD21A/0083.
