THE HIGH COURT

IN THE MATTER OF SCHUH (ROI) LIMITED ("SCHUH IRELAND") AND IN THE MATTER OF GENESCO SCHUH GMBH ("GENESCO SCHUH") AND IN THE MATTER OF THE EUROPEAN COMMUNITIES (CROSS-BORDER MERGERS) REGULATIONS 2008, AS AMENDED

NOTICE

TAKE NOTICE that:

1. Schuh Ireland and Genesco Schuh propose to effect a cross-border merger by absorption (the "Merger"), pursuant to the European Communities (Cross-Border Mergers) Regulations 2008, as amended (the "Regulations") and the relevant provisions of German legislation which transpose Directive (EU) 2017/1132 of the European Parliament and of the Council of 14 June 2017 relating to certain aspects of company law (codification), Title II of Chapter II of which relates to cross-border mergers of limited liability companies. As a result of the Merger, all of the assets and liabilities of Genesco Schuh with all attendant rights and obligations without variation or alteration, shall transfer to Schuh Ireland, with Genesco Schuh subsequently being dissolved without going into liquidation.

2. The Common Draft Terms relating to the proposed Merger and a completed Form CBM1 were delivered to the Irish Registrar of Companies on Wednesday, 2 February 2022.

3. The rights and obligations of creditors of Genesco Schuh will transfer to Schuh Ireland pursuant to the Regulations and the applicable laws of Germany as a consequence of the Merger. Under German law, the creditors of Genesco Schuh have the right to demand that security be provided if their claim(s) arose before or up to fifteen (15) days after the date of publication of the Common Draft Terms on the German Commercial Register responsible for Genesco Schuh. Under German law, any Genesco Schuh creditor who meets this requirement and wishes to exercise this right, must make the demand within a period of two (2) months after such date of publication. For this purpose, any demand must be made in writing to Genesco Schuh and must include the basis and amount of any claim(s) and substantiate that the fulfilment of the claim(s) is put at risk by the Merger. Full information on the arrangements for the exercise of the rights of creditors for Genesco Schuh may be obtained free of charge from Genesco Schuh at Innere Kanalstraße 15, 50823 Cologne, Germany C/o Osborne Clarke.

4. Creditors of Schuh Ireland may exercise their rights pursuant to Regulation 15 of the Regulations. Any creditor of Schuh Ireland that is entitled to a debt or claim against Schuh Ireland on the date of publication of this notice is entitled to be heard by the Irish High Court when the Court considers the effectiveness of the Merger pursuant to Regulation 14 of the Regulations. Any such creditor who has a concern that they will be unfairly prejudiced by the Merger should give written notice to Schuh Ireland of their objection to the Merger. The written notice should contain full details of their objection including the basis for and amount of their debt or claim and how they are unfairly prejudiced by the Merger. The notice should be sent to the Company Secretary at the address below. Any unresolved representations received from creditors will be brought to the attention of the Irish High Court at the hearing when the Court considers the effectiveness of the Merger pursuant to Regulation 14 of the Regulations. Full information on the arrangements for the exercise of the rights of creditors of Schuh Ireland may be obtained free of charge at Riverside One, Sir John Rogerson's Quay, Dublin 2 (Ref: Company Secretary).

5. All companies involved in the Merger are subsidiaries in the Schuh group, with the ultimate parent company being Genesco Inc, a company incorporated in the United States and publicly quoted on the New York Stock Exchange. Accordingly, there are no minority members. The shareholders of each merging company will be asked to consider and approve the proposed merger.
