3. Sustainable Urban Drainage Systems The applicant shall include water butts and/or domestic

rain garden with overflow to the surface water drainage network as part of SuDS (Sustainable Drainage Systems) for the proposed development. Revised drawings should be submitted to the Planning Authority for 2 agreement prior to the commencement of development. REASON: To

ensure the provision of SUDS.

4. Surface Water Drainage. The applicant has proposed to discharge surface water run off from the

proposed development to the foul water drainage network which is not acceptable. Prior to the commencement of development, the applicant shall submit a drawing to the Planning Authority for written agreement showing: (a) existing and proposed surface water drainage layouts up to and including the point of connection to the public surface water sewer. (b) existing and proposed foul water drainage layouts up to and including the point of connection to the public waste water sewer. The drawings shall include the location of all Aj's, manholes, pipe size, material type and direction of flow. The drawing shall clearly show that the foul and surface water systems are discharging to separate pipe networks. Maps of the mains foul and surface water drainage networks may be obtained, if available, for required locations in South Dublin County Council by emailing: servicemaps@sdublincoco.ie and/or datarequests@water.ie. All works are to comply with the Greater Dublin Regional Code of Practice for Drainage Works. The agreed drawings shall be fully implemented on site.
