We wish to object to the application for planning permission to site at rear of cottage at 66 Dodsborough Cottages. This site has been refused planning permission on 3 previous occasions, one of those reasons being traffic and overdevelopment. The area of Dodsborough has been negatively impacted on due to the over development of the Adamstown area and this dwelling would contribute further to that impact. The proposed dwelling will enter out onto a busy pathway and cycle lane which is a pedestrian health and safety concern.
