#### INVALID PLANNING APPLICATION

An application for Permission for the development described above was received on 08-Mar-2022.

However, the application did not comply with Part IV of the Planning and Development Regulations, 2001(as amended) for the following reason(s):-

- 1. Article 18(2)(a):- The newspaper is not from the approved list.

  The Local News (South Edition) is not from the approved list in compliance with the requirements of the Planning and Development Regulations 2001 (as amended).
- **2.** Article 18(1)(b):- The location/townland/postal address given in the Newspaper Notice is insufficiently detailed to ascertain the location of the site.

The Newspaper Notice indicates 13A which does not exist.

3. Article 22(4)(b)(ii):- Site or layout plans and drawings of floor plans, elevations and sections do not describe the works (or retention of works) to which the application relates sufficiently. The floor plans indicate scale of 1:200 which is incorrect, other measurements are also slightly incorrect.

Accordingly, I recommend that:-

(a) The applicant be advised in accordance with Part IV Article 26 (5) (a) of the Planning & Development Regulations 2001(as amended), that the application is **INVALID** and cannot be considered by the Planning Authority.
