# Lilies to Marc Dublin's card

**KERRY legend Marc Ó Sé is backing Kildare to pile on the misery for Dublin on Sunday.**

The Sky Blues have lost all three league games so far against Armagh, the Kingdom and Mayo and are rooted to the bottom of the Division 1 table.

As talk of a crisis grows, relegation fears will increase dramatically if they lose in Newbridge.

Kildare also need a result - Glenn Ryan's men have just one point on the board after their narrow defeat to Tyrone last Sunday in Omagh.

Three-time All-Star defender Ó Sé (*below*) says the hosts must use their strengths in attack to target a Dubs defence that has shipped 5-41 in just three games.

And with home advantage at St Conleth's Park, the five-time All-Ireland winner is backing the Lilywhites to plunge Dessie Farrell's men into crisis even further.

Ladbrokes.com: "Dublin are under serious pressure now."

"When have we ever seen this happen before? Jonny Cooper added a bit of steel to them last weekend but they need more players back if they're to improve."

"Both teams will be well up for it. If Dublin lose here, relegation is a huge risk at this stage so expect improvements."

"However, I think Kildare will up their game also so, for me, I'm going with a Kildare home win."

"Kildare were very unlucky not to come away with something last weekend."

"Daniel Flynn, Paul Cribbin and Jimmy Hyland all performed very well at the weekend."

"If Kildare can get early ball to Flynn and Hyland, they can definitely target what I would call a very vulnerable Dublin full-back line at the moment."

I don't think that people fully understand that we are separate associations - I don't know why

what it is and until we merge, that problem is not going to go away.

"That would be my biggest thing. We can do all we want to try to promote the game and we aren't at the mercy of the GAA in terms of crowds but we certainly are when it comes to grounds."

"We don't have the money coming in to get around that."

"Our ladies club are trying to get their own facilities, but we are at the mercy of the GAA in so many ways."

She knows a shared association for all will not be a quick fix, but it is the only solution to tackle these issues.

When Concannon moved to Abu Dhabi for two years in 2016, she joined the Na Fianna club in the United Arab Emirates, where all players were treated equally and the club facilities were for everyone.

She also feels that double-headers with men's games for league and Championship fixtures are not hap-

pening nearly as often as they should and that female athletes in other sports have less on their plate.

She said: "The double-headers don't always happen either and they do create more interest and atmosphere."

"Our club, Tuam-Cortoon used to organise buses for the Under-12s and Under-14s to go to our games."

"It was great at the time, but all you were getting was noise because Under-12s aren't really engaged in the game so it didn't really work."

"I know that with women's rugby they aren't totally happy with their set-ups either."

"But there's no hassle with fundraising for a bit of gear or food and from what I can see in general, they do get the basics."

"They have to battle for a lot less in general."
