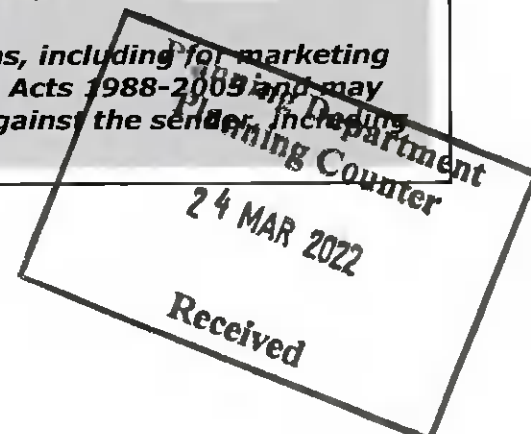

Planning permission is sought for the following:

- a. For change of use from existing short term tourist accommodation units to full apartment type living accommodation units consisting of 10 no 2 bed ground floor units and 10 no two bed duplex type units at first floor level (20 no units in total). Also, to include small elevational changes to facilitate balcony extensions at first floor level and new balcony areas at ground floor level in order to accommodate private amenity space for the individual units.
- b. The application also seeks permission to omit Planning Condition 6 of Planning Ref. S01A/0051 (which link the use of units to the City West Hotel).
- c. And a new bicycle shelter and all associated site development works, parking, landscaping and boundary treatment works, all at The Westpark Crescent, Gartons Lane, Saggart, co. Dublin.


