We, Xilinx Ireland Unlimited Company are applying for retention permission of development at this site at Bianconi Avenue, CityWest Business Campus, Saggart, Dublin, D24 T683.

The development consists of the retention of the generator compound (391sqm) consisting of three generators along with three transformers and ancillary 3 no. diesel tanks and perimeter treatment on a permanent basis on the southern perimeter of the site with Orchard Avenue.

The development also consists of the retention of 3 no. signs (10.94sqm) as follows:

- Retention of 1 no. sign (0.57sqm) on plinth at the corner of Bianconi Avenue and the N82 / CityWest Road;
- Retention of 1 no. sign (4.58sqm) on the eastern elevation of Block D facing the N82 / CityWest Road; and
- Retention of 1 no. sign (5.79sqm) on the northern elevation of Block M facing Bianconi Avenue.

The development will include retention of all revisions to the permitted landscaping and site development works required.
