To Whom it May Concern,

Please consider the below points in relation to the planning application for the new housing development in Boherboy, Saggart.

The Citywest area has now got the population of a town but without the amenities of a town. We have no community centre, No Garda Station, No GAA pitch and no Football pitches. On these plans we have a new playground opposite our houses in Carrigmore Avenue and this is going to cause antisocial behaviour and we already have this in Carrigmore Park as it is with no Garda presence.

Proposed future vehicular access to the development from Carrigmore Green, Avenue and Corbally Heath is a major safety concern, these are residential streets that children play on as they have no other areas. The streets are too narrow and can already barely cope with the traffic and parking as it is for residences.

Traffic in the area is already an issue and this is before the developments that are currently in construction are built, the area would come to a standstill with the additional traffic.

Carrigmore Avenue is already at risk of flooding and is on the boarder of being classed as Flood Risk Area for house insurance if its natural drainage is built on at this site. Is there any forward planning for drainage on site to stop Carrigmore Avenue flooding in the further because if not the residence will have to seek <u>legal action</u>?

Biodiversity is an issue here, practically all the green spaces that existed in Citywest 2 years ago will shortly be covered in cement. The government have declared a climate crisis and we continue to have no regard for nature and local wildlife.

I would appreciate if you could take into consideration the above points when deciding on the planning application for this development.
