South Dublin County Council

Citywise Education intend to apply for full planning permission on the Durkan Centre campus on Fortunestown Way, Jobstown, D24 W284. The application will extend the existing 2 storey building on site that provides after school education to students in the area, where the new building will facilitate second and third level students.

The proposal will have a new shared entrance serving both buildings. The proposed extension is a 2 storey building, matching the scale and massing of the existing building. The building has been designed to achieve a Net Zero Whole Life Carbon standard and this in part is achieved by an external brick skin, a cross laminated timber structural system, harnessing of natural light and extensive use of photovoltaic solar panels. The building programme will provide a lecture theatre, a science laboratory, classrooms, a reading room, offices, a central atrium, and a kitchen facility. The flat roof will carry solar photovoltaic solar panels and a biodiversity outdoor classroom, and all associated site works.

It is proposed to relocate the muga within the complex to the east of the existing building and provide additional outdoor sports equipment. All proposed boundary fencing will match the existing boundary treatment in size and material.


