Billy and Zaur are tit for tat

ZAUR ANTIA and Billy Walsh went 1-1 at the Women's World Championships in Istanbul yesterday as three Irish fighters marched on.

The coaching duo led Ireland to seven medals across the 2008 and 2012 Olympic Games.

Now they are in the corner for Ireland and the USA respectively, with their fighters meeting twice yesterday.

After Walsh's departure, Antia told SunSport: "In the ring, we are enemies. Outside the ring we will remain brothers."

And it was first blood to the Georgian as Belfast featherweight Michaela Walsh scored a unanimous win over Amelia Moore.

But Wexford man Billy Walsh evened the score when his middleweight Naomi Graham eliminated former European champ Aoife O'Rourke by split decision.

Ireland had two other winners on the day.

Louth light-welterweight Amy Broadhurst — fresh from a stint in the USA where she sparred with Katie Taylor ahead of the Amanda Serrano super-fight — kicked off her competition with a dominant win.

And, in the last Irish action of the day, Belfast flyweight Carly McNaul beat Burundian Ornella Havyarimana to slide into the next round.

Star fighter Kellie Harrington is out injured.

Wade on the mend

DARTS ace James Wade will not take part in tonight's Premier League outing in Sheffield as he recovers from illness.

The world No 5 spent three nights in hospital in Germany after taking ill during the Interwetten European Open on Sunday.

The 39-year-old withdrew following a quarter-final win in Leverkusen and was taken to a local hospital.

He underwent tests on Monday and Tuesday before being cleared to return home to the UK yesterday.

Wade said: "I'd like to thank all the medical staff for their care and also the fans around the world who sent messages of support."

"I'll be taking time to recover fully before returning to playing when the time is right."

Wade's quarter-final opponent in Sheffield, Joe Cullen, is awarded a 6-0 win and progresses to the semi-final.

Arnold: I can't make the same mistake Tou times

TOULOUSE lock Rory Arnold has admitted he was lucky not to be sent off last week against Munster.

And he believes that would have all but guaranteed a Munster-Leinster semi-final at the Aviva Stadium this weekend.

Arnold saw yellow for a spear tackle on Simon Zebo — with the referee determining it was not a red as the Munster man landed on his back rather than his head.

On whether it should have been a yellow or a red, the Toulouse man admitted: "When they slowed it down, there wasn't much in it. I definitely got that one wrong."

"If I was shown red then it changed the outcome of that game. I was very lucky there and I need to be better around that collision zone."

Trailing 21-14 when he was sent to the sin bin, when he returned the gap was ten points but Toulouse fought back to force extra-time and then penalties to advance to Saturday's semi-final at the same venue.

THE golf world is about to be plunged into a civil war as the blazing row over players being barred from the €240million LIV Golf Series escalates.

Greg Norman (below) — chief executive of the Saudi Arabia-backed breakaway circuit — insisted he is not looking for a legal battle.

But he vowed to foot the lawyers' bills for any players who decide to take their case to the courts.

And he warned of "injunctions ready to go" if there is any attempt to stop LIV participants from teeing off in the Majors or Ryder Cup.

The Australian gave a shock response to a question about the killing of journalist Jamal Khashoggi by agents of the Saudi regime, replying: "We all make mistakes" — before desperately backtracking in a bid to show he was not trying to play down the Saudis' human rights record.

Monahan announced a blanket ban on the first of eight LIV tournaments, at Centurion Club in St Albans, England, from June 9-11. The DP World Tour quickly followed with the same warning.

The event offers nearly €23.5m in prize money — twice as much as The Open in July — with the winner collecting €3.8m.
