1.0 INTRODUCTION

- 1.1 The purpose of this report is to provide an audit of the existing community facilities serving the Tallaght area. It provides information on the key population changes occurring in the area and the potential demographic changes arising from the redevelopment opportunities within this area. The report contains an audit of the existing social infrastructure in the area relating to:
 - Community and social infrastructure;
 - Open space, sport and recreation;
 - Educational facilities:
 - Healthcare facilities;
 - Religious facilities;
 - Arts and cultural facilities; and
 - Retail provision.
- 1.2 These facilities are assessed to support the proposed development of the subject site for residential use. In particular this Assessment will demonstrate that there is sufficient community facilities provision within the study area to cater for the future needs of the population, therefore the development of the subject lands will not result in a loss of community related activities.
- 1.3 This report has been prepared on behalf of Landmarque Belgard Development Company Ltd. who propose to develop lands for a residential development, including 334 no. units (212 residential units which includes 3 no. live-work units and 122 Build-to-Rent residential units), new tertiary route to the south, public open space, communal open space and landscaping, car parking access, residential amenity spaces, drainage infrastructure and parking on a brownfield site. A crèche and 4 no. commercial units are also proposed.
- 1.4 The purpose of this Social Infrastructure Assessment is to determine if the Tallaght area is well served by community related facilities to support the future residents of the proposed development. The study also forms an important information tool that can be used in the consideration of the redevelopment of other lands in the area.
- 1.5 The site currently provides no community facility or open space for public use. In addition to the residential uses, the proposed development will comprise of public open space including two pocket parks, a tertiary pedestrian route enhancing the public realm and permeability, 4 No. commercial units and 4 no. commercial units associated with the 4 no. live-work units (530 sqm combined), west to east tertiary route to surrounding areas. The proposal will also provide for a childcare (creche) facility which will benefit the local area, and the existing and future residents. These new commercial units will increase the variety of uses and mix in the area. Therefore the proposed development will result in a significant contribution to community facilities in the area.
- 1.6 We note the provisions of the Tallaght Town Centre Local Area Plan 2020–2026. In particular the following:
 - "It is the policy of the Council to promote Tallaght as the priority location for regional level community and social infrastructure in the County. In addition, South Dublin County Council will facilitate the expansion and enhancement of existing community facilities and to facilitate the provision of a range of new community facilities in tandem with population growth to meet the needs of future residents of Tallaght (Objective CF 1)."

1.7 In addition, we note the Tallaght LAP also includes a Social Infrastructure Audit within 'Appendix 4' which aims is 'to examine and analyse the availability and capacity of existing social infrastructure facilities in Tallaght, and to determine future requirements, and make recommendations based on anticipated settlement growth'. Using this document as a key reference point we had prepared this Social Infrastructure Assessment.

2.0 INTRODUCTION TO TALLAGHT

- 2.1 Tallaght is a large settlement located c.10 km south-west of Dublin City Centre and approximately 2 km west of the M50, which connects Tallaght to the wider national motorway network.
- 2.2 Tallaght is the largest settlement and the county town of South Dublin County, and the largest satellite town of Dublin City.
- 2.3 The original village developed on the site of a monastic settlement from the 8th century. Up until the 1960s Tallaght was a small village with a population of c.2,500.
- 2.4 Suburban development began in Tallaght during the 1970s as one of Dublin's "new towns" including Clondalkin, Lucan and Blanchardstown. Over the proceeding years Tallaght developed rapidly with its distinct identity.
- 2.5 Tallaght is highly accessible generally, in particular by public transport such as Luas and bus connecting it to Dublin City Centre. In terms of road infrastructure the settlement is principally served by the N81, which links the settlement to the M50, the national motorway network and the Greater Dublin Area.
- 2.6 The Whitestown Stream, a tributary of the Dodder River runs south of Tallaght Town Centre through the Sean Walsh Memorial Park. The Tallaght Town Centre Local Area Plan 2020 relates to an area of approximately 380 hectares, and the area expected to be able to accommodate between 8,410 to 11,090 new homes; 7,800 to 15,300 additional jobs; and a population of up to 34,000 people in the beyond the life of the LAP. The population of the electoral divisions that make up Tallaght is 76,119 (CSO, 2016).
- 2.7 The Town Centre is the centre of civic activity in the County with its range of commercial, social and cultural activities. Due to its proximity to Dublin and Wicklow mountains it is also close to a range of recreational areas and scenic landscapes.

3.0 TALLAGHT AREA CONTEXT

- 3.1 Tallaght is situated on the southern extent of Dublin City and Suburbs, just north of the Dublin Mountains. There are many large scale employment areas in close proximity including Tallaght Hospital, South Dublin County Council, Cookstown Industrial Estate and Tallaght Business Park.
- 3.2 Tallaght is highly accessible via a number of means. The N81 road connects the town centre to the M50 and national motorway network. A range of Dublin Bus routes connects the town centre to the wider Dublin area including the No.'s 27, 49, 54a, 65, 75, 77A, 175.
- 3.3 The Luas Redline provides a high frequency direct connection with Dublin City Centre.
- 3.4 It is anticipated that Tallaght will be served by Bus Connects Core Route Corridor No. 9 'Greenhills to City Centre' in the near future.




Figure 3.1: Tallaght wider context (Source: Google Maps, 2022).




Figure 3.2: Location of the subject site in relation to Tallaght Town Centre (approximate outline in red; Source: Google Maps, 2022).

- 3.5 Figure 3.1 below shows the locational context of Tallaght. Figure 3.2 shows the subject site in the context of Tallaght town.
- 3.6 We note South Dublin County Council has voted to approve an ambitious programme of work at the April 2021 called the 'Cycle South Dublin'. The approved programme seeks to progress works on new and improved cycle lanes across the County. The programme includes 63 projects that would deliver approximately 260km of space for cycling and walking. This is an increase of nearly 50km from the programme that was publicly consulted on in late 2020.

4.0 POLICY CONTEXT

- 4.1 The subject site is located within the Tallaght Town Centre Local Area Plan 2020–2026 ('The LAP') environs, as such this LAP is a key reference point. The LAP states:
- 4.2 "It is the policy of the Council to promote Tallaght as the priority location for regional level community and social infrastructure in the County. In addition, South Dublin County Council will facilitate the expansion and enhancement of existing community facilities and to facilitate the provision of a range of new community facilities in tandem with population growth to meet the needs of future residents of Tallaght (Objective CF 1)."
- 4.3 The LAP also includes a Social Infrastructure Audit within 'Appendix 4' which aims is 'to examine and analyse the availability and capacity of existing social infrastructure facilities in Tallaght, and to determine future requirements, and make recommendations based on anticipated settlement growth'. Using this document as a basis we have prepared this Social Infrastructure Assessment to support the proposed development.
- 4.4 The Local Area Plan itself requires:
 - "Applicants for significant developments (100+ units) will be required to submit a social infrastructure assessment to include an implementation and phasing programme, which demonstrates the facilities available/required to adequately service their development."
- 4.5 In response to the recommendations of the LAP, the proposed development will make a contribution to the creation of sustainable neighbourhoods as set out in full in Section 6.0 of this report. Primarily this will be through a high-quality residential scheme, public realm, new tertiary route, childcare facility and retail uses.
- 4.6 We also note the provisions of the South Dublin Development Plan 2016, the overall aim of the Development Plan with regard to community infrastructure is to support the planned provision of accessible community and recreational facilities, parks and open spaces.
- 4.7 Table 5.2 of the Development Plan sets out relevant county plan development management policies for community development and an evaluation of the proposed development.
- 4.8 Policy C1 states: "It is the policy of the Council to ensure that all communities have access to multifunctional community centres that provide a focal point for community activities".

5.0 DEMOGRAPHICS

- 5.1 In order to determine a profile of the immediate area for this Audit, it was decided to use to Electoral Division (ED) Tallaght-Springfield as per the CSO SAPMAP, as seen in Figure 5.1 below. As set out in the National Planning Framework, the most recent figures project the population of South Dublin to grow from 279,000 to 308,000 314,000 by 2026; and 320,500 329,000 by 2031.
- 5.2 The figures used for the study area were obtained from the 2011 and 2016 Census. The 2021 Census was delayed due to the impact of Covid-19 Pandemic and relate to the Tallaght-Springfield ED of Tallaght. The following areas are discussed:
 - Population;
 - Age Profile;
 - Social Class and Employment; and
 - Educational Attainment.

5.4 The table above shows the age profile of the Tallaght area in comparison to the State. The above figure shows that Tallaght has a generally younger population profile than seen more widely in the State with individuals ages 20-39 comprising the largest age group.

- 5.5 The table above shows that the Tallaght area has an above average amount of the population at work, at 55.8% compared to the State average of 53.4% however it also has a higher than average percentage of unemployed at 10.4%. This is related to a lower percentage of the population still in education at 7.8%. Since March 2020, the CSO has been producing a supplementary measure of monthly unemployment in parallel with the routine Monthly Unemployment Estimates, which incorporates those in receipt of the Pandemic Unemployment Payment (PUP) into the calculation to produce a COVID-19 Adjusted Measure of Monthly Unemployment.
- 5.6 The COVID-19 Adjusted Measure of Employment for the number of employed persons aged 15-89 years, decreased from 2,439,099 to 2,430,587 between the end of December 2021 and the end of January 2022. This was accompanied by a decrease from 70.9% in December 2021 to 70.7% in January 2022 in the associated COVID-19 Adjusted Employment Rate for those aged 15-64.

- 5.7 The figures presented in Table 5.3 suggest that the Tallaght area has a close employment trend when compared to the State average. In terms of social class, the above table demonstrates that the Tallaght-Springfield ED has a lower percent of the population working as Professional workers and Managerial and technical. Within the ED workers are more evenly distributed across categories managerial and technical, non-manual, manual and semi-skilled. With a higher population involved in skilled manual work, semi-skilled, and unskilled compare to the State averages.
- 5.8 The social class of an area is directly related to educational attainment. This will be further discussed below.

5.9 As can be seen from Table 5.4 above, the Tallaght-Springfield area has a lower average level of educational attainment in most third level considerations. For example,

the percentage of the population with no formal education in Tallaght (2.2%) is greater than the State average (1.6%). Education attainment at primary / secondary level is similar to the state averages. However, the percentage of the population in Tallaght a Technical or Vocational qualification exceeds the State average, with figures of 11.6% and 8.7%, respectively.

6.0 EXISTING COMMUNITY FACILITIES

- 6.1 A survey was carried out of the existing social infrastructure in the defined study area under the following headings:
 - Community and Social Infrastructure
 - Open Space, Sport and Recreation
 - Education Facilities
 - Healthcare Facilities
 - Religious Facilities
 - Arts & Cultural Facilities
 - Retail.




Figure 6.1: Overview of Community facilities within 2km of the subject site.

- 6.2 In addition we have mapped the key resources within 2 km of the subject site in the above categories. 2 km is considered a reasonable maximum distance to travel via range of transport including walking, cycling and public transport. The area is well provided for in many regards, as such the list is not exhaustive due to the number of such facilities nearby, instead the survey focuses on the most convenient and relevant. The site is regarded as being extremely well connected to existing community facilities (as can be seen in Figure 6.1).

Community and Social Infrastructure

- 6.3 Quality neighbourhoods should be responsive to the needs of local communities, play an important role in quality of life factors and foster a wider sense of community and active citizenship. The LAP outlines many of the essential services in existence.
- 6.4 Community Facilities are considered to include youth services, local authority offices, welfare services, libraries, Garda and fire stations, and community services.
- 6.5 Tallaght has a strong network of community groups and clubs, many of which are voluntary groups. Our survey identified a large range of community facilities within the study area
- 6.6 Key providers in the area include Belgard Youth and Community Centre, Dominic's Community Centre Fettercairn Community Centre, *inter alia*. These facilities provide an essential role in responding to local community needs.
- 6.7 Tallaght also has a large-scale library. Libraries provide useful facilities to local residents including free broadband and wireless internet service, self-service printing/scanning, photocopying, study space, children's learning zone, garden space, citizen's information centre, large print book collection, daily newspapers as well as application forms for motor tax, passport etc. and a community noticeboard / information.

Open Space, Sport & Recreation

- 6.8 The purpose of this audit is to support the provision of residential development on the subject site in that the study area is well served by existing community facilities which will adequately serve the needs of the future residents.
- 6.9 Recreation and open space are an important part of every community's life. They require pro-active encouragement and enhancement to ensure participation by all within the local community. This section of the audit seeks to identify the type, functions, location and maintenance requirements of open spaces within the wider area and includes:
 - An assessment of the quality and condition of facilities and fitness for purpose;
 - The levels of use, needs and differing aspirations for open space by the Tallaght community; and
 - An evaluation of the existing provision against the identified needs, such as to identify areas of deficiency or surplus and other issues and opportunities.
- 6.10 The immediate area has a large range of open space areas suitable for cycling, running and walking. Despite its predominately developed and urban character, there are a range of open space and recreation areas nearby. For the purposes of this study open space and recreation facilities are considered to include parks, playgrounds, multi-use games areas, leisure facilities and sports pitches used by GAA, football and other clubs.
- 6.11 Quality recreation, leisure and amenity facilities have a fundamental impact on quality of life. It can improve social integration and cohesiveness. Sporting, recreation and leisure activities are of primary importance to the quality of life enjoyed by the local community




Figure 6.7: Overview of Open Space and Recreation Facilities within 2km.

- 6.12 There are a number of larger key parks discussed in detail below in addition to other open spaces and sport facilities in the vicinity (see accompanying map Figure 6.7).

(1) Sean Walsh Park

- 6.13 Sean Walsh Park is located in the heart of Tallaght on the N81. It comprises formal gardens, water features such as ponds and waterfalls, trees and vegetation provide variations and allows shaded areas for relaxation. Pedestrian paths around the ponds allow for a pleasant walks and passive recreation.
- 6.14 Other facilities at the park include a sensory garden and playground.

(2) Tymon Park

- 6.15 Tymon Park is a valuable resource for the local communities and the surrounding neighbourhoods. At 120 ha. in size, it provides opportunities for a wide range of outdoor active and passive recreational activities for all age groups including walking, jogging and participation in active sport including playing pitches for GAA, soccer and rugby and numerous playgrounds.
- 6.16 The Park has a number of woodland trails which include the provision of way-markers and signs to guide the visitor along woodland trails with on-site interpretation of features.
- 6.17 The park has two lakes with interconnecting water features. The environment around the lakes is enhanced by the pedestrian paths and bridges.

(3) Dodder Riverbank Park

- 6.18 The Dodder Valley Park follows the Dodder through South Dublin from the Dublin Mountains through Tallaght to Ringsend, it is a unique and valuable recreational asset for the people of South Dublin. The Dodder Valley supports a rich variety of birds, animals and insects.
- 6.19 In addition to its natural conservation value, the park offers a rich heritage, outstanding scenery and a sanctuary for peaceful recreation.

(4) <u>Dublin Mountains Way</u>

6.20 The Dublin Mountains Way is a waymarked long-distance trail in the Dublin Mountains, which begins nearby in the Tallaght Industrial Estate and connects South County Dublin with Dún Laoghaire–Rathdown. The route is approximately 42 kilometres long and runs from Shankill in the east through the Dublin Mountains to Tallaght in the west.

6.21 The route links Tallaght with many recreational areas in the Dublin Mountains such as Killtipper Park and Bohernabreena Reservoir in the Dublin Mountains.

Educational Facilities

- 6.22 The following range of education facilities including: pre / after school, primary, secondary, third level colleges and further education facilities were identified within close proximity of the subject site.
- 6.23 The map below illustrates the high concentration of schools within a 2km radius of the subject site. Appendix 1-2 lists details of individuals facilities. The below figures were obtained from the latest Department of Education statistics for the year 2021/22.1
- 6.24 The proposed development includes a childcare facility; the rationale and justification for this facility is set out in Appendix 3. These figures were obtained from the latest statistics available on the TUSLA Register of Early Year Services (February 2022).²




Figure 6.8: Overview of Education Facilities within 2km with approximate locations.

Primary Schools

- 6.25 The primary education sector includes a range of school types, including: state-funded schools, special schools and private primary schools. The state-funded schools include religious schools, nondenominational schools, multi-denominational schools and Gaelscoileanna (Irish-medium schools).
- 6.26 The State pays the bulk of the building and running costs of state-funded primary schools. Although children are not obliged to attend school until the age of six, almost all children begin school in the September following their fourth birthday. Nearly 40% of four-year-olds and almost all five-year-olds are enrolled in infant classes in primary schools (sometimes called national schools). Primary education consists of an eight year cycle: junior infants, senior infants, and first to sixth classes. Pupils normally transfer to post-primary education at the age of twelve.
- 6.27 We note 18 No. primary schools within 2 km of the subject site, catering for 5,831 No. pupils. Please see Appendix 2 for full list of these primary schools.

Secondary Schools

- 6.28 The post-primary education sector comprises secondary, vocational, community and comprehensive schools. Secondary schools are privately owned and managed. Vocational schools are state-established and administered by Education and Training Boards (ETBs), while community and comprehensive schools are managed by Boards of Management.
- 6.29 Post-primary education consists of a three-year Junior Cycle (lower secondary), followed by a two or three year Senior Cycle (upper secondary), depending on whether the optional Transition Year (TY) is taken.
- 6.30 Students usually begin the Junior Cycle at age 12. The Junior Certificate examination is taken after three years. The main objective of the Junior Cycle is for students to complete abroad and balanced curriculum, and to develop the knowledge and skills that will enable them to proceed to Senior Cycle education The Senior Cycle caters for students in the 15 to 18 year age group. It includes an optional Transition Year, which follows immediately after the Junior Cycle. We have surveyed the number of schools in the wider 2km area, as these schools are likely to serve the future residents of the proposed development.
- 6.31 We note 4 No. post-primary schools within 2km of the subject site, catering for 3,013 No. pupils. Please see Appendix 3 for full list of these post-primary schools. We also note Firhouse Community College (805 No. pupils) and Tallaght Community School (754 No. pupils lie just outside the 2km radius of the site.

Childcare Facilities

- 6.32 Within c.1 km we noted 13 No. childcare facilities providing a range of services from full day to sessional for a range of age profile with a cumulative capacity for 641 No. children. We have prepared a childcare facility assessment as part of this application within Appendix 3 which sets out full details of individual childcare facilities.
- 6.33 Considering the proposed development's characteristics, namely unit mix; the demographic profile of the area; and, the permitted provision of childcare facilities; and the scale of development existing, under construction and permitted for the area, we submit that the proposed childcare facilities are sufficient to meet the demand of the future population created by the proposed development.
- 6.34 The provision of a Creche/Childcare Facility of c.144 sqm (equating to c. 48 no. child spaces), in combination with recently permitted and existing childcare facilities in the area, meets the requirements of delivering this proposed scheme of development.

Third Level and Further Education

- 6.35 Third-level education in the Republic of Ireland includes all education after second-level, encompassing higher education in universities and colleges and further education on Post Leaving Certificate (PLC) and other courses.
- 6.36 There are a number of third level institutes in the surrounding area which include:
 - Technological University Dublin's Tallaght Campus is located c.300 m east of the subject site. The university was formed by the amalgamation of three existing institutes of technology in the Dublin area Dublin Institute of Technology, Institute of Technology, Blanchardstown, and Institute of Technology, Tallaght. TU Dublin now has over 3,000 staff and a student population of 28,500. Its ethos focuses on an entrepreneurial and industry approach, with extensive collaboration with industry for research and teaching.
 - Tallaght Training Centre form part of the Dublin and Dun Laoghaire Education and Training Board (DDLETB) which serves the three County areas of Dun Laoghaire-Rathdown, Fingal and South Dublin. The Centre offers a range of day and night courses for individuals to improve their job prospects or return to education. Located at the DDLETB Tallaght Training Centre Cookstown Industrial Estate, Third Ave, Tallaght, Dublin 24.
 - Given the highly accessible nature of the site other large scale universities such as Trinity College and University College Dublin are conveniently accessible via public transport (Luas and Bus respectively).
- 6.37 It is clear that Tallaght is well served by all education facilities.

Healthcare Facilities

6.38 Healthcare within the study area is provided by a range of different organisations including public, voluntary and private agencies. The Health Services Executive is the primary agency responsible for delivering health and personal social services in Ireland. In recent years, primary care has been identified as the most effective and cost-efficient way to treat patients. This offsets dependence on the hospital system allowing most patient care to take place at local, community locations which feature multi-disciplinary teams of healthcare professionals working together.

- 6.39 For specialist services individuals may be willing to travel further, as the proposed development is located within the Great Dublin Area it has access to national public hospitals, private hospitals, high-tech hospitals, accident and emergency services, psychiatric hospitals, rehabilitation centres, orthopaedic hospital and hospices.
- 6.40 Many of the healthcare facilities are clustered around the Square Shopping Centre. Tallaght University Hospital is the closest large scale hospital to the subject site. In addition there are 2 other primary care centres in the area including Kilnamanagh Tymon Primary Care Centre and the Academic and Primary Care Centre (APCC), at Tallaght Cross.

Religious Facilities

- 6.41 Religious and community facilities are a very important part in the provision of neighbourhood facilities. Tallaght town is a long established town in South County Dublin and has a range of religious facilities. In many cases, as described below community facilities are associated with these religious facilities.
- 6.42 The predominant religion in the Republic of Ireland is Christianity, with the largest church being the Catholic Church. The second largest Christian denomination, the Church of Ireland (Anglican) has more recently experienced an increase, as have other small Christian denominations.
- 6.43 In the 2016 census, 78.8% (3.7 million) of the population identified as Catholic which is 132,220 fewer than the 2011 census when the percentage stood at 84%.
- 6.44 The next largest group after Catholic was "no religion". 10% of the population (468,421 people) had no religion or did not indicate a religious belief according to the census. Other religious recorded in the Census included: Eastern Orthodox (1.3%), Islam (1.3%), Presbyterian (0.5%), Hindu (0.3%), Apostolic or Pentecostal (0.3%) and 'Not Stated' or 'Other' (4.8 %).
- 6.45 The site borders the Tallaght Architectural Conservation Area which contains St Mealruen's Church yard which is early Medieval. Directly to the east of the Church is the former Archbishop's Palace, now part of the St Mary's Dominican Priory. The late medieval gatehouse is all that survives of the Archbishop's Palace of the later medieval period.

6.46 In the Springfield-Tallaght ED the population is more diverse:




Figure 6.10: Overview of Religious Facilities within 2km.

Arts & Cultural Facilities

- 6.47 It is widely recognised that arts and culture are key cornerstones in the sustainable development of new communities, helping to define and preserve identity, promote social activity, and offer valuable educational and economic returns. County Dublin has a strong network of artists, performers and musicians promoting cultural activities.
- 6.48 South Dublin County Council Arts Office provides a service that supports the development of creative people and communities through the Arts. Provision and support of high quality arts experiences are central to the service. This is realised through research, programmes, events, grants and awards and the development of on-line and off-line resources.
- 6.49 The following arts and cultural facilities have been identified in the study and provided a variety of uses to the community:

Civic Theatre

The Civic Theatre, opened in March 1999, a project of SDCC. The Civic Theatre's aim is to present programme of contemporary and classical Irish and international work in theatre, dance, opera and music for the community of South Dublin county and environs.

Rua Red

Rua Red is a contemporary art space housing two galleries, a theatre/cinema, a dance studio, a conference room, a digital media suite, recording facilities, music rooms, workshop areas, artist's studios, office space and a café. Rua Red exhibit the work of established Irish and International artists.

Retail

- 6.50 Tallaght has a wide range of choice and type of retail uses in the immediate area. Key retail facilities are concentrated in the Square Shopping Centre and Tallaght Village. In addition there are a number of neighbourhood and local centres catering for more everyday needs.
- 6.51 The Square Shopping Centre is a large scale shopping centre providing a huge range of shops and services.
- 6.52 The following mix of retail uses were noted in these neighbourhood and local centres:

- Clothes and retail
- Book shops
- Restaurants and cafes
- Hairdressers and barbers
- Pharmacies
- Electronics
- Discount food stores
- Post office
- Banks and credit unions
- Mechanics and Car repairs
- Social welfare and other civic services (Intreo Centre Tallaght)
- 6.53 It is considered that the subject proposal will further develop and enhance the retail offering in the town, particularly with regard to convenience shopping. The proposed development will help support the provision of additional retail facilities in the village centre.




Figure 6.11: Key Retail Facilities in Tallaght within 2km.

7.0 DEVELOPMENT PROPOSAL AT THE ABB SITE

- 7.1 It is considered that the proposed development will make a significant contribution to the built environment in Tallaght.
- 7.2 The development proposal has considered all of the requirements of the LAP and the Development, in particular the provision of the following:
 - Public open space
 - Tertiary connection with surrounding area
 - Childcare facility;
 - Retail uses
- 7.3 Each of the above uses/ facilities are addressed below:

Public Open Space

7.4 Detailed consideration has been given to the provision of public open space and landscaping within the development. The landscaping masterplan for the site has incorporated a number of different landscaped areas, such as courtyards, playgrounds, passive open space and active open space. The proposed landscaping significantly enhances the overall quality of the scheme, improving the natural environment and incorporation of the scheme within the wider area.

Childcare Facility

7.5 A Childcare Facility will be developed on the site in accordance with the requirements of the Childcare Guidelines and will be accessible to both the existing and future residents. The proposed crèche (144 sqm) providing for approximately c. 48 childcare spaces will be located along the south of the development.

Retail Units

7.6 Retail uses are provided across the development at ground level providing activity, services and retail for the wider area.

Tertiary Route / Linear Park

7.7 A tertiary route is provided at approximately 11 metres in width along the southern boundary of the site, in accordance with the Local Area Plan. This new permeable route provides for pedestrian and cycle movements east west which are not present with the current building on site. The development therefore contributes to public open space, permeability and legibility of the wider area, providing an attractive connection which has been designed to ensure passive surveillance and activity with the uses along this edge. This public open space provides for a set back from the property to south and allows for the potential expansion of the public realm if redevelopment occurs of this property ensuring future urban design compatibility with this site.

8.0 CONCLUSION

- 8.1 The purpose of this Assessment is to determine if the Tallaght area is well served by community related facilities to support the future residents of the proposed development.
- 8.2 In summary, it is considered that Tallaght is accessible to a range open space and recreational facilities including; Tymon Park, Sean Walsh Park and Dodder Valley Park a large number of education facilities including a third level university; and a large quantum of community and retail facilities located throughout the Town Centre. As such the facilities that Tallaght currently offers are excellent and will being able to support the future residents of the proposed development.
- 8.3 The site currently provides no contribution to the built environment through public realm or retail for public use. The proposed development will include public open space, childcare, retail and a high quality tertiary route which will benefit the existing and the future residents in the area.

APPENDIX 3: CHILDCARE FACILITIES ASSESSMENT

1.0 INTRODUCTION

- 1.1 The purpose of this Appendix is to provide an audit of the existing childcare facilities serving an area of approximately 1 km from the subject site. The report provides information on the key demographics and population changes within the area.
- 1.2 There are currently 13 no. creche facilities within the study area (c. 1 km radius of the subject site), these facilities are assessed to support the proposed development of the subject site for residential use.
- 1.3 The provision of a Creche/Childcare Facility of c.144 sqm (equating to c. 48 no. child spaces), in combination with recently permitted and existing childcare facilities in the area, meets the requirements of delivering this proposed scheme of development.

2.0 ASSESSMENT




Figure 1: Map showing study area boundary outlined in black.

2.1 The method for establishing the local demographic profile comprise a brief overview of the Tallaght town centre. The overall study area based on the Electoral District is detailed in Figure 1 below.

2.2 The emerging demographic profile of this area should provide a reliable gauge as to the current and future requirements for the provision of childcare places in the area. As further outlined in Section 4 Demographics, (2016 census) we have studied the overall population of the subject area in addition to focusing on a number of specific age and gender categories, as well as referencing percentage figures in respect of the 2016 census.

3.0 DEMOGRAPHICS

- 3.1 The demographic trends for the study area are obtained from both the 2011 and 2016 Census and primary relate to settlement boundary of Tallaght town centre.
- 3.2 The population of the Local Authority Area and the study areas are displayed below. The population of the county and the study area recorded a much greater growth rate above than the State rate, the study area recorded a growth of 7.7%. This is reflective of the fact that the study area contains a number of new housing developments constructed in Tallaght town centre up until 2016.

3.3 However, what is more critical is to examine the age breakdown of the population within the study area. Firstly, at County level, South Dublin County experienced a decrease of -5.7% in the number of pre-school population (0-4 years old) between 2011 and 2016. See below map from cso.ie.




Figure 2: Map showing percentage change in pre-school population in South Dublin (Source: CSO.ie).

3.4 Analysis of the study area was carried out using the Small Area Population Statistics on the CSO website. The Study Area is shown in Figure 1 above. The application site is outlined within the study area.

- 3.5 The following points were concluded from the above analysis:
 - 7.3% of the population in the study area is aged 0-4, a slight increase from the 2011 figure when it was 7.2%. This represents a pre-school population of 2,305 children for the study area in 2016.
 - 16.5% of the female population in the study area is aged 25-44, which is down on the corresponding figure from 2011 of 15.8%
- 3.6 Compared to state level figures (5.4%), the study area comprises on average 1.9% more children under the age of 4 and a higher number of females between the ages of 25-44. The demand for childcare would be based upon both the aforementioned categories.

4.0 EXISTING CHILCARE FACILITIES

- 4.1 We have carried out a review of the existing childcare facilities in the area. The below map shows that there are 13 no. creche facilities within 1km of the subject site and a further 21 within a 2km radius.
- 4.2 The existing facilities cater for a broad range of ages, these facilities have a combined capacity to accommodate 1,394 spaces.




Figure 3: Map from pobal.ie showing creche facilites within 1km and 2km radius of the subject site

- 4.3 In addition we also note the following permitted childcare facilities in proximity to the subject site:
 - SHD Application: ABP-303803-19 Units 5A 5C Second Avenue, Cookstown Industrial Estate, Tallaght, Dublin 24 including creche of 192 sqm.
 - o SHD Application: ABP-303306-18 Junction of Belgard Road and Belgard Square North, Tallaght, Dublin 24 including creche of 380 sqm.

- o **SHD Application: ABP 305763**: Site at the corner of Airton Road and Belgard Road, Tallaght, Dublin 24 including creche of 360 sgm.
- SHD Application ABP 306705: Permission was granted in 2020 for the construction of 502 no. apartments including a creche of Airton Road and Greenhills Road, approx. 500m east of the subject site.
- SHD application: ABP 308398-20: permission was granted in 2021 for development at Units 66 and 67 Fourth Avenue, Cookstown Industrial Estate, Tallaght, Dublin24 including a creche of 274.5 sqm.
- SHD application ABP-309916-21: permission granted for development at Glen Abbey Complex, Belgard Road, Cookstown Industrial Estate, Dublin 24 Square for 170 No. units including a childcare unit of 163 sqm
- 4.4 As evidenced by Table 2 above there are a large number of childcare providers in close proximity to the application site, current capacity provides c. 641 childcare places for the local population. However this needs to be compared against the actual number of pre-school children living in the catchment area, and in particular those who are likely to require such childcare facilities. We would also note, that it would be required to confirm that these facilities remain operating, as there have been a number of facilities closed due to the Covid 19 pandemic. As such, we are mindful that consideration may be necessary of those creche businesses that maintain operation in light of recent economic events. This report is not an 'audit' of 'open/ closed', but a reflection of those registered with Tulsa at the date of the survey'
- 4.5 From Census figures it is possible to estimate the percentage of the pre-school population who actually attend childcare facilities versus the numbers who are minded by parents or other family members or other home-based childcare arrangements.
- 4.6 According to the 2016 census there was approximately 2,305 no. pre-school children in the study area. Q3 2016 census figures on childcare outlined that the percentage of pre-school children that are minded by their parent(s) is 62%. The most commonly used non-parental childcare type for pre-school children is a crèche/ Montessori/ playgroup/ after-school facility. Nationally, his type of care is used by 19% of pre-school children, with the highest rate of use being in Dublin at 25%.
- 4.7 Furthermore, some 49% of pre-school children living in a household where both parents are present use non-parental childcare. In lone parent households, 37% of pre-school children use non-parental childcare.

4.8 The Quarterly National Household Survey (QNHS) carried out by the Central Statistics Office includes a Special Module on Childcare. The most recent report on this module was published for Quarter 4 2016 (See Appendix A below).

- 4.9 The figures indicate is that 25% of pre-school children in the Dublin attend private childcare (i.e. creche, Montessori etc.). The vast majority are either cared for by the parents, relative, family friend, or a paid nanny based in the family home.
- 4.10 Taking a conservative amount of 35% of pre-school children that use childcare facilities, this would result in a requirement for c. 807 no. spaces (please note this does not include the requirement for children aged 5-6 years which may also avail of childcare/afterschool care). As shown above the study area has a capacity of c. 830 no. spaces. As such, it is considered that within the study area there is likely adequate capacity for existing needs; however available capacity is limited and thus any future developments will most likely need to provide childcare services to cater for the additional demand for childcare spaces by the new resident population.

5.0 POLICY CONTEXT

- 5.1 Childcare Facilities Guidelines for Planning Authorities published in June 2001 provide a framework to guide both local authorities in preparing development plans and assessing applications for planning permission, and developers and childcare providers in formulating development proposals.
- 5.2 The Guidelines state that the local authority policies should focus on: "The identification of appropriate locations for the provision of childcare facilities including city centres, district centres, neighbourhood centres, residential areas, places of employment, and educational institutions and convenience to public transport nodes as a key element in the development of sustainable communities." The LAP and Development Plan both reflect the intent of these Guidelines.
- 5.3 The following objectives are relevant to the provision of childcare services within the LAP area of Tallaght:
 - "It is policy of the plan to facilitate the sustainable development of good quality and accessible early childhood care (early years and general childcare both home based and centre based) and education infrastructure (Objective CF 4).
- 5.4 The Plan states that "In individual applications for large scale residential development, the developer shall demonstrate available provision (existing or committed) is provided in the catchment. The plan supports proposals for early childhood care and education use within employment buildings, community buildings such as community centres and schools. Early childhood care in existing residential units should only be provided at an appropriate scale to complement purpose built facilities and are subject to appropriate safeguards."
- 5.5 The Local Area Plan also states that following in relation to new development in the town centre "The indicative long-term unit growth for the area would generate a minimum requirement for 270 spaces. All new residential developments and particularly those in excess of a 10-minute walk-time from existing childcare facilities with sufficient capacity to accommodate that development, will be required to comply with the minimum childcare standards and the provision of childcare facilities as part of specific developments."
- 5.6 The Section 28 Sustainable Urban Housing; Design Standards for New Apartments; Guidelines for Planning Authorities 2018 states that:

"Notwithstanding the Department's Planning Guidelines for Childcare Facilities, in respect of which a review is to be progressed, and which recommend the provision of one child-care facility (equivalent to a minimum of 20 child places) for every 75 dwelling units, the threshold for provision of any such facilities in apartment schemes should be established having regard to the scale and unit mix of the proposed development and the existing geographical distribution of childcare facilities and the emerging demographic profile of the area. One-bedroom or studio type units should not generally be considered to contribute to a requirement for any childcare provision and subject to location, this may also apply in part or whole, to units with two or more bedrooms".

- 5.7 The overall proposed development provides for 344 no. residential units. However, the 1 bedroom units are discounted when calculating the childcare provision, as provided for by the 2020 Apartment Guidelines. As such, the childcare spaces required is therefore calculated as [(334-193) / 75 x 20 = 37.6 spaces].
- 5.8 Based on the above assessment, the proposed development will need to provide for the childcare need generated by the proposed development.

6.0 CONCLUSION

- 6.1 Considering the proposed development's characteristics, namely unit mix; the demographic profile of the area; and, the permitted provision of childcare facilities; and the scale of development existing, permitted for the area, we submit that the proposed childcare facilities are sufficient to meet the demand of the future population created by the proposed development.
- 6.2 The provision of a creche/childcare facility of c.144 sqm (equating to c. 48 no. child spaces), in combination with recently permitted and existing childcare facilities in the area, meets the requirements of delivering this proposed scheme of development.
