On behalf of Interxion Ireland DAC., we wish to apply for permission for development at this site at Grange Castle Business Park, Clondalkin, Dublin 22.

The development will consist of amendments and modifications to the permitted data centre development granted under Reg. Ref. SD18A/0323 to include: 1 no. screened bin compound to be relocated to the south-east corner of the site; 2 no. transformers within individual compounds and adjoining switch room (35.2sqm) to be located to the east of the permitted data centre to replace screened transformer compound to the south-east of the site; 1 no. new plantroom (19.8sqm) and 1 no. water storage tank to be located to the west of the permitted data centre to replace previously approved fire suppression enclosure; and New double gates to replace sliding gates at entrance into the permitted data centre site.
