The 'Meanwhile Use' includes a beer garden structure currently referred to as 'Après Ski' (c. 89 sq m) that serves as a bar and provides seating covered by the provisions of the Civil Law (Miscellaneous Provisions) Act 2021, which, inter alia, makes provision 'on a temporary basis, for the sale or supply of intoxicating liquor in certain circumstances in seating areas located outside licensed premises in order to allow, in the public interest and having regard to the manifest and grave risk to human life and public health posed by the spread of the disease known as Covid-19, the businesses of licensees to operate in a manner that mitigates the spread of that disease; to provide for the application of certain enactments to those outdoor seating areas.' In addition, the Section 28, Guidelines for Planning Authorities - Enforcement of Certain Planning Conditions during the Coronavirus (COVID-19) outbreak (29 March 2020) details that 'given the exceptional challenges arising from COVID-19, it is critical that support is given to restaurants and cafes to allow them to maximise opportunities to maintain a revenue stream' and that 'given the serious danger to public health and the resultant pressures placed on the restaurant and cafe sector, planning authorities should take an accommodating and flexible approach to conditions restricting the provision of delivery and take-away services' and that 'any breaches of planning condition in relation to restaurants or cafes operating a delivery take-away service to be 'of a minor nature', other than where issues arise which could seriously impact on public health and safety'. **Emma is Rad-y for French Open**

**EMMA RADUCANU** has revealed she is loving hitting the gym in her new training regime after declaring herself fit for her first French Open. The US Open champion feared that she would miss the clay court Grand Slam after pulling out of the Rome Masters with a lower back injury. She has had a string of physical ailments since her New York success, contracting Covid-19 in December and then suffering from blisters and hip and back problems. But the No.12 seed, who will face Czech qualifier Linda Noskova, ranked world No.185, in the first round on Monday, said she is now pumping iron to build up her body for the ups and downs of pro tennis. "I'm very happy to be able to play this tournament and fortunately I didn't have to miss this Grand Slam," said the British No.1. "There was doubt I would be here, it was definitely thrown into question."

**Worried** She then withdrew citing mental health struggles and revealed she had been suffering from depression since her 2018 US Open win. At her pre-tournament press conference, Osaka said: "When I first came here, I was very worried that there were people that I offended in some way and I would just bump into them. "But everyone has been really positive." Cameron Norrie will face Slovakian world No.47 Alex Molcan in today's final of the Lyon Open after beating Holger Rune 6-2 5-7 6-4 in the semi-finals. Norrie said: "It's never easy finishing a match. To have the break there in the second and then I kind of gifted a couple of easy ones. "I was pretty mad inside but I managed to stay composed. "It's nice to get over the line again, especially when the nerves are there. "Hopefully I can go a step further and win the title. It's perfect preparation for Roland Garros."

**Element** "I'm learning about my body and just figuring out what works physically, because that is an element of my game that needs to be looked at. "I have been doing a lot more in the gym to try and fire up those muscles, keep the stability and do some rehab. "I am working on my whole body but right now especially my core area. It's something I'm definitely learning to enjoy with each bit that I do. "I get that positive reinforcement and I feel really good about myself. "And it helps you mentally as well if you know that you

**EVANS SLAMS SLAM**

**DAN EVANS** has slammed the decision to strip Wimbledon of ranking points following the ban on Russian and Belarusian players. The ATP and WTA have made the unprecedented decision to remove all the points from the grass-court Grand Slam tournament. And the men's professional stars such as Daniil Medvedev and Andrey Rublev should have been allowed to compete after they had all signed a declaration stating that they did not support Russia's war in Ukraine. "The ability for players of any nationality to enter tournaments based on merit, and without discrimination, is fundamental to our Tour," the ATP said in a statement.

**Points** But British No 2 Evans (left) said: "We should all still be playing for ranking points at Wimbledon. "If we're sticking it solely on tennis and not politics there should be points. "There are a lot of other people losing out because of a small minority who are missing the tournament."
