I am writing to you to advise that subject to Section 58D(1) of the Child & Family Agency Act 2013, your service is now re-registered and has been placed on the Register of Early Years Services. There are no conditions attached to this registration.

The period of registration as pursuant to Section 58D(4) will be three years from 1<sup>st</sup> January 2020 to 1<sup>st</sup> January 2023. Your certificate of registration will follow in January 2020.

Please note, where this applies these documents must be submitted on or before June 30<sup>th</sup>, 2020. All policies required by the Child Care Act 1991 (Early Years Services) Regulations 2016 will be examined on inspection and should be available in your service at all times.

As previously advised any Change in Circumstance received on application that requires a Fit for Purpose inspection will be processed from January 2020. Such changes should not be implemented until approval has been granted by the Registration team.
