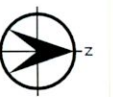
OVERALL SITE LAYOUT

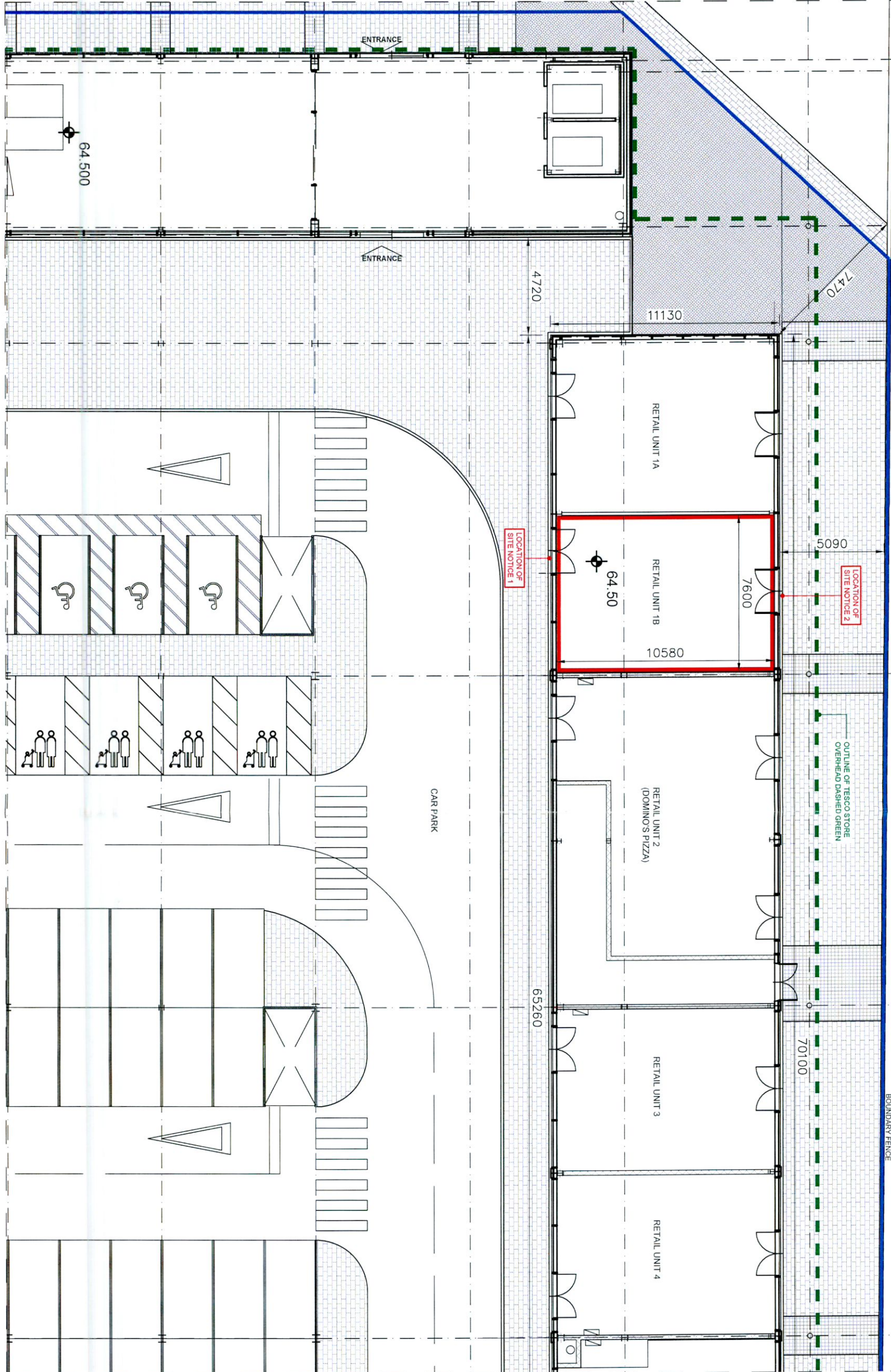
