I refer to the above planning permission issued by South Dublin County Council on 3rd March 2022. It is Irish Water's intention to commence the development and to discharge the requirements of the following conditions 2, 4, 5, 8(Part 2), 8(Part 4), 8 (Part 5).

In compliance with Condition No. 2 please find attached the datasheet, including photographs (*LWG-BIM-F-089 Safe Grid- General Utility*), of the proposed architectural screening of the lime dosing buildings/silo to demonstrate the design and size of the perforations. A sample of the cladding will be delivered to the Planning Department in the coming days.

In compliance with Condition No. 4, please find attached the Bat Survey and Walkover Ecological Survey undertaken on 14th December 2021 by David Fallon, on behalf of Irish Water. Irish Water can also confirm that the services of a qualified ecologist will be retained for the duration of the development.

In compliance with Condition No. 5, please find attached the response provided by the National Monuments Service to the request made under Section 12(3) of the National Monuments (Amendment) Act 1994 on 18th January 2022 (*Email dated 3rd February 2022, Ref: NM05924, S12 Notification of Works at DU017-075001 and DU017-079---Cooldrinagh, Co. Dublin*). Attached also for information, are the Response to Request for Further Information Report (*4041_ Leixlip RFI Response_Issue_v03 inc Appendices*) and the Preliminary Archaeological Assessment (*4041-Leixlip WTP Upgrade-Preliminary Archaeological Assessment_Rev3.3*), prepared by Ryan Hanly, which are referenced in the National Monuments Service response. Irish Water can confirm that the National Monuments Service has no additional requirements.

In compliance with Condition No. 8 (Part 1) please find attached the proposed ducting layout for the development which indicates that 100% of surface car parking spaces will be provided with electrical ducting (11118-GAL-LP2-XX-DR-W-3006_Dosing and Ducting Layout Part 1). Further details will follow regarding charging points and signage, once available.

In compliance with Condition No. 8 (Part 2 and Part 4) please find attached the Construction Traffic Management Plan (*Drawing No: 20 CC003 Rev 0*) prepared by MEIC, the Construction and Demolition Waste Management Plan (*1118-GAL-LP-ZZ-DC-W-8010-Leixlip Phase2b Waste Management Plan*) prepared by Glan Agua. With regards to Part 5 of this condition, Irish Water note there is no proposed amendment to public lighting as a result of the development. Attached, for information, are the proposed building lighting schemes (internal to the site) for the lime dosing, acid dosing and workshop buildings (*11118-GAL-06-DR-W-7604_Workshop Building Lighting Layout, 11118-GAL-LP2-06-DR-W-7601_Lime Dosing Building-Lighting Layout*)

Please note that Irish Water expect to be in a position to discharge Condition No. 6, the final pre-commencement condition, later this week.

We trust that the enclosed will satisfactorily address the requirements of the conditions. Given the nature of the project, we respectfully request that the compliance submission is dealt with at your earliest convenience in order to allow the project to proceed without delay.
