We wish to object to the above planning application lodged on 20 June 2022.

- 1. In the Applicants letter dated 16th June 2022 they state the existing gateposts are 'really two narrow for use by modern cars'. There are two accessible car parking spaces on the driveway which were created by the previous owner. It would seem that the occupants of number 30 have no problem accessing the driveway (shared with number 32) in their vehicles.
- 2. We believe the gatepost at number 32 has already been moved and does not need to be moved further.
- 3. In many of the examples provided the Applicants are not comparing like with like. The vast majority of properties in the district have not changed or widened their original gateposts and very few have removed parts of the verge / curb (widening of the dishing).
- 4. The Applicants proposal involves the reduction of existing on-street car parking. Any reduction in on-street parking will affect all residents in the area. There is already a severe shortage of on-street public parking on this and surrounding roads.
- 5. In their written application and in the drawings tendered as part of their application, the Applicants do not make any reference to the existing mature Cherry Tree in the grass verge between numbers 34 and 32. The roots of this long standing tree, the last remaining mature tree on the turning circle, occupy and are prominent in the grass verge. The Applicants proposal to remove any part of the grass verge and widening of the dishing will, if permitted, involve the removal and destruction of the roots of this mature tree. Such work, if permitted,

will most likely result in the destruction of a mature tree and its removal along with the grass verge.

- 6. In the written application reference is made to widening of the dishing at number 36. This is incorrect the grass verge and curb have not been altered and we would question the accuracy of the drawing in respect of the grass verge at this entrance.
- 7. Should the Applicants proposal be permitted it will affect the aesthetic of the immediate area.
