With reference to the above application, I would like to request the following amendments to the proposed plans are considered:


- 1. With reference to the proposed works to the attic dormer on the side (north) elevation, due to overlooking we would like the proposed top hung window either:
- a). Removed and replaced with a rooflight to protect the privacy of our ensuite bathroom window which is located opposite and below the line of this proposed window

or

b). the opening section is replaced with a fixed pane.

We note and agree that the window should be permanantly frosted.

2. With reference to the proposed works to the attic on the side (north) elevation, due to the proposed dormer structure overshadowing the sunlight we currently enjoy from our south facing attic rooflight, we would like the confirguration of the stairs to be slightly altered that by removing 3 risers to the longer first flight and adding them to the second flight. This would reduce the neccessity of the dormer height of 8.615m by approximately 600mm




- 3. With reference to the proposed works to the ground floor extension on the side (north) elevation, due to excessive overshadowing as the proposed extension is due south of our back garden, we would request the proposed roof height is reduced to 3m, which would be a slight increase on the existing height of the current wall.
- 4. With respect to the proposed works in the garden, where "existing garden decking to be replaced with new structure to be made up with bricks to match extension; hardcore infill, new concrete tiles and new steel railing" is proposed, we request that the FFL of this new area be no less than 2m from the finished height of the existing garden boundary wall, to prevent any overlooking into our rear garden.
