
Dear sir/madam,

I have one observation on this application. With reference to the proposed elevation (front) drawings, I note that on the house to the right (i.e., 26 Butterfield Close), the landing window is shown as being positioned higher that the bedroom window to its left. However, in actual fact, the landing window on that property is lower (by some distance) than the bedroom window to its left.

This apparent error may be of relevance in the context of the proposed new storage shed which, if built to the currently proposed height, could have the effect of blocking, or limiting, light into the landing window of no. 26 Butterfield Close.

i trust that the above observation is of assistance.
