#### To whom it may concern,

I am making the following observations in relation to the planning application SDZ 22A/0010. My observations relate to the access road into Whitton Ave. I bought my home (9 Whitton Ave) from Green light developments ltd. who advertised the properties as a 9 dwelling cul de sac. We were made aware of the Clonburris development but told that we would always be a cul de sac. I am keen to keep the cul de sac as it is and I am proposing that we keep the access we already have onto the 9th Louth rd. This new spur road will also impact on the safety of our children in the estate. Rather than the walking onto a pedestrianised and enclosed area as is there now, we would exit onto a main road.

As in the plans, there is to be duplex complexes in front of Whitton Ave. Consideration should be given to a tiered effect and a gradation in height moving away from Whitton Ave. A tree line between the proposed new development should be considered also.

An inspectors report with An Bord Pleanála was done by our neighbouring Cappaghmore residents ( see images attached) it states that the trees and it's roots along the estate must be retained. From the new plans I can see that the tree adjacent to 9 Whitton Ave and to the rear of Cappaghmore is being kept but is the roots of the tree been taking into account. A house and a driveway will be in close proximity to the roots of those trees.

In the proposed plans, there seems to be little consideration for the wild animals that live on that land. I understand keeping some of the trees etc. will help, but a number of fauna in particular should be noted. There are foxes, rabbits, many small birds etc. buy in particular there is bats and a buzzard that hunts on the land.

I am hoping that the council, the planners and the developers could meet to discuss the future of the area and the impact that some decisions could have on the people that already live in the area.

put that it felt that the best trees were, in fact, located within the estate.

I have carefully locked at the location (see my photographs in Appendix 1), and I accept that the concern of the residents is a real one. I note that the variation / modification no. 35, which required that "a tree survey be incorporated into the new development and trees worthy of retention identified and and Mr Scannell, this would not ensure the trees would be retained, and I accept that, as worded, the decision as to what trees merited retention could be seen as something to be decided by the applicant for planning permission, or by the Development Agency with no right of appeal by the residents. In addition, the variation does not deal with the issue of new buildings being proposed too close to the trees, and hence interfering with their root systems (and ultimately having to be felled).

In order to deal with this issue, so as to ensure that these trees are protected in the Scheme and thus taken on board when planning applications are under consideration in due course, I consider that it would be prudent to include a specific reference in the relevant neighbourhood drawing (SDZ.01 Cappagh). This can be done by adding an additional paragraph under site sensitivities with the following text:

X

4. Trees along boundary with Cappamore estate to be retained, and buildings set back a sufficient distance from the trees to avoid interference with their root systems."

In addition, the numeral 4 should be provided, at a number of points along the Cappamore estate boundary, on the neighbourhood drawing. It follows from this that the Development Agency's Variation / Modification no. 35 should be significantly amended.

A similar modification should be made to the Development Agency's Variation / Modification no. 36, which deals with a similar issue in relation to trees at Ashwood.

### 3. School and Childcare Provision

The issue of school provision, which featured large in the many submission made to the Development Agency prior to the adoption of the Scheme, was n

**Reason:** In the interests of clarity, and in order to limit the impacts of the Scheme on the neighbouring lands in the interests of residential amenity and traffic and pedestrian safety.

9. Insert footnote below Table of development schedule for SDZ.06 – Kishogue Bridge, to state as follows:- "any wholly-residential individual development proposal submitted for planning approval in the Kishogue Bridge neighbourhood shall have an average net density of not less than 75 dwellings per hectare"

**Reason:** In the interests of clarity, and in order to reasonably facilitate the implementation of sustainable development within the Scheme area.

10 (1) Modify Design Code drawings M.03.e (Station Road east) and M.03.w (Station Road west) (plans and sections) so that the road has an overall width of 25.4 metres, and has 3 metre wide bus lanes and 1.2 metre wide raised and adjacent cycle lanes on each side, instead of the 3.5 metre wide combined bus and cycle lanes, and modify the text in the paragraphs headed 'Urban Design function' in each case to substitute for 'a dedicated bus and cycle lane' the words "dedicated and separate bus and cycle lanes".

Kelland Homes Ltd. intends to apply for permission for development on a site area of 6.3Ha, on lands within the townland of Cappagh, Dublin 22. The proposed development is located west of the Ninth Lock Road, south of the Dublin-Cork railway line, north of Cappaghmore housing estate and Whitton Avenue, and east of an existing carpark / park & ride facility at the Clondalkin Fonthill train station and the R113 (Fonthill Road). The proposed development is located within the Clonburris Strategic Development Zone (SDZ), within the development areas of (I) Clonburris South East (i.e. CSE-S1 & CSE-S2) and (ii) part of Clonburris Urban Centre (i.e. CUC-54), as identified in the Clonburris SDZ Planning Scheme 2019. The proposed development consists of the construction of 294 no. dwellings, creche and retail / commercial unit, which are comprised of: 118 no. 2, 3 & 4 bed, 2 storey semi-detached and terraced houses, 104 no. 2 & 3 bfd duplex units accommodated in 10 no. 3 storey buildings, 72 no. f & 2 bedroom apartments in 2 no. 4 & 6 storey buildings, 1 no. 2 storey creche (c.520.2m2), 1 no. 2 storey retail /commercial unit (c.152.1m2). Access to the development will by via the permitted road network (under Ref. SDZ20A/0021) which provides access from the Ninth Lock Road to the east and the R113 (Fonthill Road) to the west. The proposed development will connect into the permitted Infrastructural works as approved under the Clonburris Strategic Development Zona Planning Scl1ame (2019) and permitted under Ref. SDZ20A/0021, with the proposed development connecting into the permitted surface water drainage attenuation systems i.e. 1 no. pond, 3 no. modular underground storage systems and 1 no. detention basin combined modular underground systems. The proposed infrastructure will connect into a permitted foul pumping station and pipe network within proposed road corridors to facilitate drainage connections to future wastewater drainage infrastructure within the adjoining SOZ lands (Including future Irish Water pumping station station permitted under SDZ21A/0006). The proposed development also provides for all associated site development works above and below ground, public & communal open spaces, hard & soft landscaping and boundary treatments, surface car parking (401 no. spaces), bicycle parking (797 no. spaces), bin & bicycle storage, public lighting, plant (M&E), utility services & 4 no.
