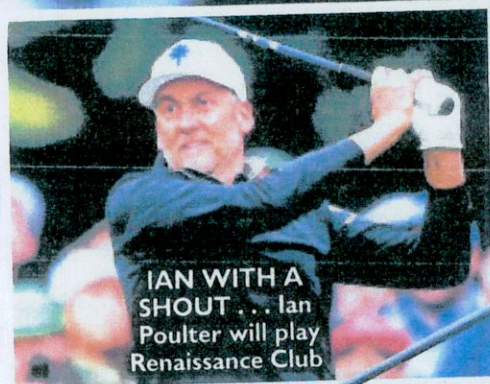

JT LIVs for a challenge THOMAS TO KO REBELS

JUSTIN THOMAS admits winning the Scottish Open would be made sweeter if it came at the expense of one of the LIV rebels.

DP World Tour players who contested the first Saudi breakaway event at Centurion Club last month were fined £100,000 and banned from the Renaissance Club this weekend but successfully appealed the sanctions on Monday.

Ian Poulter, Justin Harding, Adrian Otaegui and Branden Grace were then added to the field.

Asked about the possibility of playing with one this weekend, US PGA champion Thomas said: "If I know all four of them, then it will be fine. It will be easy."

"But even if I don't, I don't necessarily think we're going to be having any, like, gamesmanship or needing each other out there."

"At the end of the day, they are here for the same reason we are and that's just trying to play well and give yourself an opportunity to win the Scottish Open."

"If it so happens that it comes to that point and you have an opportunity to beat one of them to win the tournament, it might be a little better, but I'm sure they would say the same thing."

Thomas warmed up for the event with a golfing tour of Ireland last weekend, that included rounds

at Lahinch and Tralee Golf Clubs before playing the JP McManus Pro-Am at Adare Manor.

He and Rory McIlroy (below) have emerged as the most prominent supporters of the PGA Tour in its battle against the rival circuit.

But the two-time Major winner is keen to concentrate on his game ahead of next week's 150th Open Championship at St Andrews.

The American said: "I'll be the first to say I've gotten wrapped up emotionally from time to time, and I'm allowed to do that."

"I'm passionate about it and I feel a certain way. But at the end of the day, myself and others, first and foremost, need to focus on playing good golf because that's the number one priority."

"But if we can continue to focus on improving our product, getting our product as good as possible, then at the end of the day we have nothing to worry about."

"You never know what's going to happen in terms of other entities or other things being thrown out there."

"But I think we're all obviously very pleased with where we are at and we are just continuing to make strides and progress and changes that are going to benefit everybody."
