

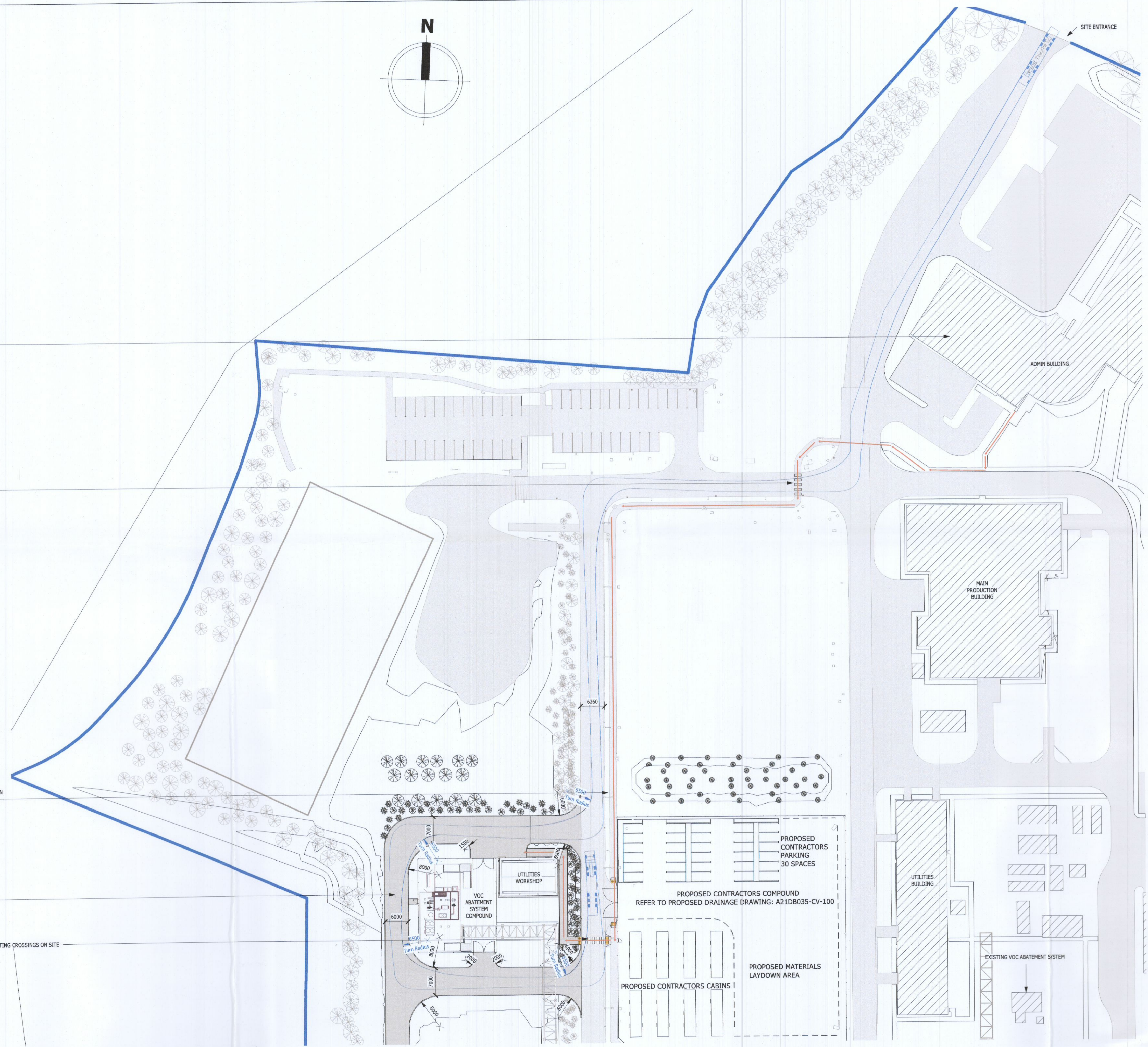

EXISTING ILLUMINATED PEDESTRIAN CROSSING

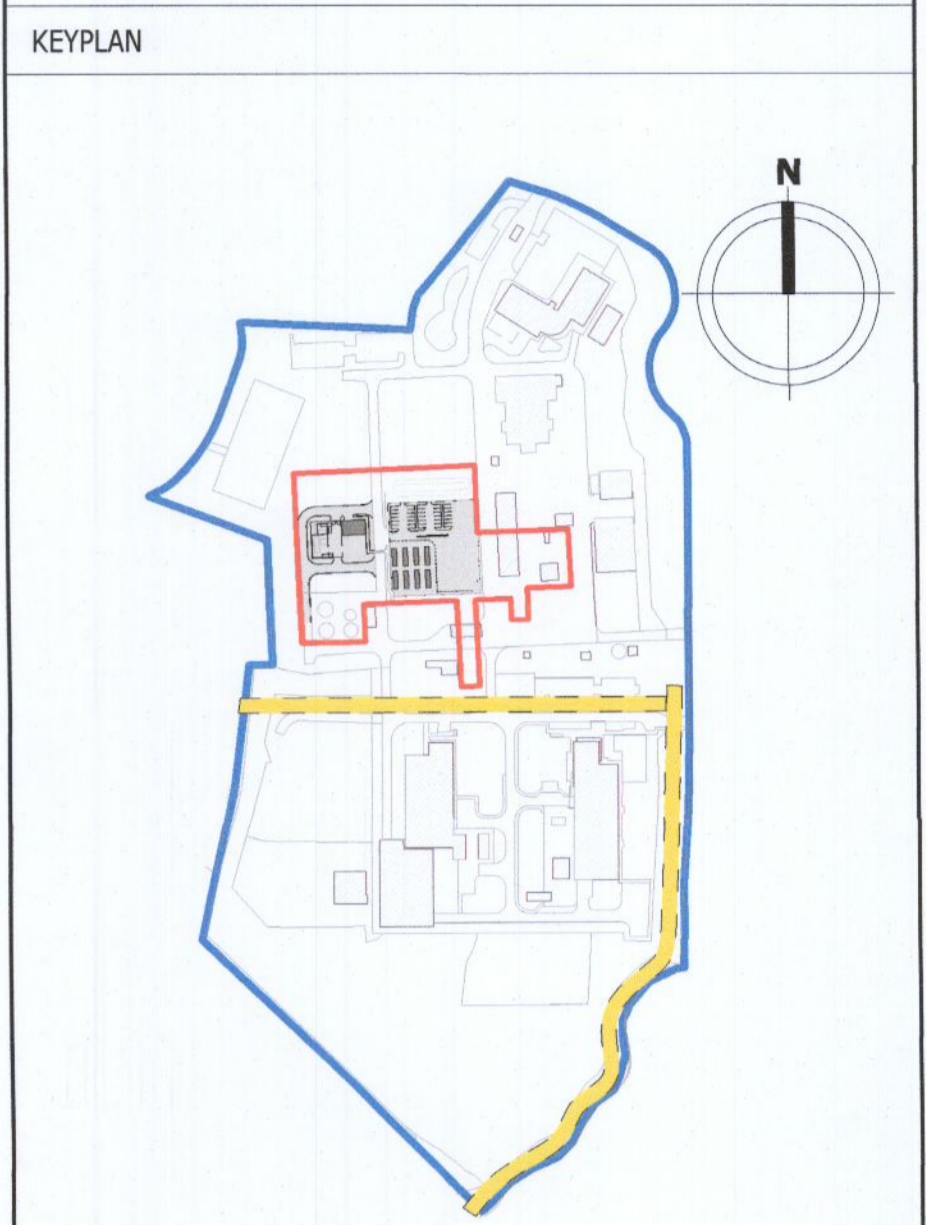
EXISTING ILLUMINATED ACCESS ROAD & PEDESTRIAN FOOTPATH
