In accordance with article 22(1) (d) we wish to confirm that the lands are currently in the ownership of P & R Doyle Ltd., Unit B1-B2, Greenogue Industrial Estate, Greenogue, Rathcoole, Co. Dublin, D24 YH34.

In accordance with article 22(2) (b) of S. I. No. 600 of 2001 the lands which are the subject of this application are outlined in red on the enclosed Ordnance Survey Map sheet no. 3388-A at scale 1:1,000 and also on Drg. No. 22/418/1 at 1:250 scale. There are no wayleaves necessary to enable this development to proceed.

In accordance with article 22(2) (c) of S. I. No. 600 of 2001 the approximate location of the site notice erected is identified on Ordnance Survey Map sheet no. 3388-A. As no application has been made on the subject lands in the past 6 months the Site Notice has been erected on white paper.

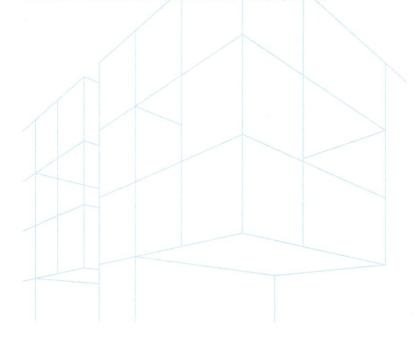
