Padraig Thornton Waste Disposal Ltd. t/a Thorntons Recycling intends to apply for permission for development at the existing waste recovery facility located at Unit 518B, Grants Crescent, Greenogue Business Park, Rathcoole, Co. Dublin, D24 NY97. The development will consist of (i) a new waste handling building (561 m<sup>2</sup> and 12 m high); (ii) the use of an existing building (159 m<sup>2</sup> and 7.5 m high) granted retention permission under SD22A/0100 for waste handling; (iii) elevational treatment including signage to the northern façade of the existing building granted retention permission under SD22A/0100; (iv) continued use of the existing building (427 m<sup>2</sup> and 8.2 m high) granted permission under SD06A/1097; and (v) all ancillary site works.

The development will comprise an activity requiring a review of the existing waste facility permit (WFP-DS-11-0002-06). The proposed development includes an increase in the total maximum annual waste intake to 20,000 tonnes.

An Environmental Impact Assessment Report (EIAR) has been submitted with this application.
