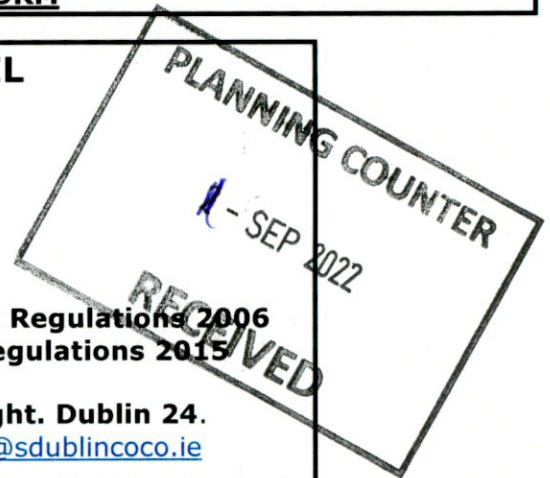

THE PROPOSED DEVELOPMENT COMPRISES OF THE DEMOLITION OF 1 NO. RESIDENTIAL PROPERTY AND 1 NO. ANCILLARY OUTBUILDING AND WILL CONSIST OF THE CONSTRUCTION OF A RESIDENTIAL DEVELOPMENT OF 42 NO. 3 BEDROOM DWELLINGS IN A MIX OF TERRACED AND SEMI-DETACHED UNITS.
