Jean Notaro & Jim Doyle are applying for planning permission for the proposed development of a new south facing, 3 storeys, 3 bedroom, flat roofed dwelling with self-coloured render and vertical timber cladding finish, on a site at the rear of no.1 The Crescent, Cooldrinagh, Lucan, Co. Dublin, K78 K0F8 (Protected structure - SDCC RPS No.095 / MAP No. 095). The development involves the splitting of the existing site in two while retaining the existing 3 storeys over basement dwelling as-is. The proposed site to the rear will have an area of 125.8m² and the dwelling will have a total floor area of 150.3m². The application includes an accessible screened roof garden, front facing screened balcony, an internal courtyard, proposed services, all associated site works and a new vehicular entry with a sliding gate off the R835.
