Permission is also sought for minor revisions to elevations comprising new access doors and a new window (mezzanine level) on the rear (north) elevation and a new escape door on front (south) elevation and associated signage on the north, south and west elevations comprising of 2no. shopfront signs, 6no. signage boards, 3no. wall mounted signs and 2no. service door signs.
