

Sydney ace in Ireland's RL squad

AUSTRALIAN Luke Keary and Super League finalists Richie Myler and James Bentley are the headline inclusions in Ireland's 24-man Rugby League World Cup squad.

Sydney Roosters half-back Keary, who qualifies through his father, had been due to make his debut at the last World Cup in 2017 but missed the tournament through injury.

He is one of five NRL players, with 12 from Super League, including captain George King and his brother Toby.

There are 15 potential debutants in new coach Ged Corcoran's squad, including Harry Rushton, Huddersfield's new signing from Canberra.

Ireland open their campaign against Jamaica at Headingley on Sunday, October 16 and also

play New Zealand and Lebanon in their group.
