AMENDMENT TO PLANNING APPLICATION:

Residential development at: -Kiltipper Road, Tallaght, Dublin 24.

Dear Sir/Madam,

We write further to the above referenced planning application. The project is now well advanced, and work is currently ongoing on the Duplex Units at the southern end of the site.

As you will be aware there are, at present, serious difficulties within the construction industry in Ireland sourcing particular sectors of labour and this can have a serious knock-on effect to programming of works. On this particular project we have experienced a shortage of block layers and in order to stay on target for the projected handover of much anticipated units we have switched to constructing the Duplex Units using ICF (Insulated Concrete Formwork). This necessitated an overall review which included consideration of the external elevations. Material and labour costs in Ireland are rising exponentially and consideration has also been given to altering the external finish of the rear elevations of the Duplex Units to change from brick to plaster. This alteration also applies to the side and front of the end units to each row. It is our view that this is a minor alteration and it would help in making construction of the Duplex Units more viable whilst not detracting from the overall aesthetic of the project.

We would be grateful if the Planning Authority could consider this proposal and if in order, issue a letter confirming same.
