Planning permission is sought for the redevelopment of Saint Claires Villa, Lucan Road. The Development will consist of the following:

1. Demolition of the existing two storey detached dwelling house and outbuildings.

 - a. A new physiotherapy practice, consisting of 5 consultation rooms, office space, staff areas as well as a rehab gym and studio area, all over two floors at ground and first floor levels.


