Permission is sought by Michael and Rachel Duncan for development at 50 Lucan Heights, Lucan, Co. Dublin, K78 T1K0. The development will consist of the following (i) Fitting of external insulation and new render to the external walls, together with the fitting of new triple glazed windows throughout and minor modifications to the front façade; (ii) Construction of an extension of 9 sq.M, which is to be built at first floor level and is to be set back from the front façade with a new hipped roof connecting to the main roof, containing a new bathroom; (iii) The construction of a single storey outbuilding of some 38 sq.M, consisting of a home office and plant room to be built in the rear garden positioned along the northern boundary of the site.
