**HORNER LEFT FRUSTRATED AS VERSTAPPEN CLOSES IN**

**CHRISTIAN Horner fears Max Verstappen's title bid this weekend could hit the skids over the budget-cap controversy.** Reports last week that the Red Bull and Aston Martin teams allegedly broke the rules by breaching budget limits last season have drawn an angry reaction in the sport. **And it comes just as Verstappen, who has a 104-point lead over Charles Leclerc in the championship, will wrap up a second title with victory in tomorrow's Japanese Grand Prix and by posting the fastest lap for an extra point.**

**Spoiler** But Horner expressed his annoyance that the budget cap debate was being used as a spoiler to dampen his star driver's chances. **"It's a big weekend for Max," said Horner. "It's a possibility rather than a probability, but, effectively, it's another match point for him. So that's what we're focused on."** **"To be honest, all the rest of the noise that has been around other topics, one can only think it's designed to be a bit of a distraction. "We are very happy with**

**Neil RANDON** where our submission for the [budget] cap is and all focus is on this weekend." The budget cap investigation - with an FIA report due to be published on Monday - also gave seven-time world champion Lewis Hamilton a chance to speak out yesterday.

**Swung** Hamilton suggested the outcome of last season's bitter championship battle with Red Bull could have swung in his favour had Mercedes overspent on car upgrades the way Red Bull are alleged to have done. **"If we spent €300,000 on a new floor, or adapted a wing,**

it would have changed the outcome of the championship naturally," the Briton said. **With rain falling for most of the first day of practice yesterday, Hamilton's Mercedes team led the field, finishing 1-2 in the time charts, with fellow Brit and teammate George Russell fastest by 0.235secs.** Verstappen was 0.851 further back in third.

**Chilled** "It's been a very chilled day," Hamilton said, as he reflected on the return to the iconic Suzuka track for the first time since 2019. **"This track is just beautiful to drive. When you do your first lap of the weekend, you think of all the legends who raced here, and at the last chicane, when Ayrton Senna and Alain Prost crashed together [in 1989]. "This track has so much history and you feel privileged to be able to race here."** With dry weather forecast for qualifying and potential showers for tomorrow's race, discovering the car's true race pace around the circuit is guesswork. **"I have no idea how we will be on Saturday," said Hamilton. "When it's dry, the Ferraris and the Red Bulls will be quite quick again. I hope we are fast."**
