

New Roof Windows:

"Velux" type roof windows to further

New Soffits & Fascias: Soffits & fascias grey pvc or Zinc

New Rainwater Goods: Rainwater goods in grey pvc or Zinc

New Cills:

Cills in concrete painted, granite or pressed metal in selected colour.

New Plinth:

Plinth in sand / cement render to match existing as near as possible painted selected colour.

New Wall Finish:

Wall finish in sand / cement render with smooth finish painted selected colour & selected brick where indicated

New Windows & Doors:

Double / triple glazed windows & doors in timber, aluclad, aluminium or upvc to match existing as near as possible in style & colour.

New roofs:

New slates to match existing cottage roof, or similar approved

New Flat roofs:


Proprietary flat roof finish system membrane, Resitrix or similar approved, with concrete or stone capping as indicated

New patios, paths and hard surfaces:

Will be laid on well graded "grit" sand, 2-5mm apart, with joints filled with kiln dried fine sand. Surface water to be discharged locally, no rain water will be discharged to public Sewer

Front Original Cottage:

All finishes to be unchanged, restored, and windows replaced to comply with building regulations

NEW SURFACE WATER FROM NEW ROOFS TO BE DISCHARGED TO NEW SOAKAWAY IN THE REAR GARDEN. ALL PAVINGS AND PATIOS WILL BE LAID ON WELL GRADED "GRIT" SAND, 2-5MM APART, WITH JOINTS FILLED WITH KILN DRIED FINE SAND. SURFACE WATER TO BE DISCHARGED LOCALLY, NO RAIN WATER WILL BE DISCHARGED TO PUBLIC
