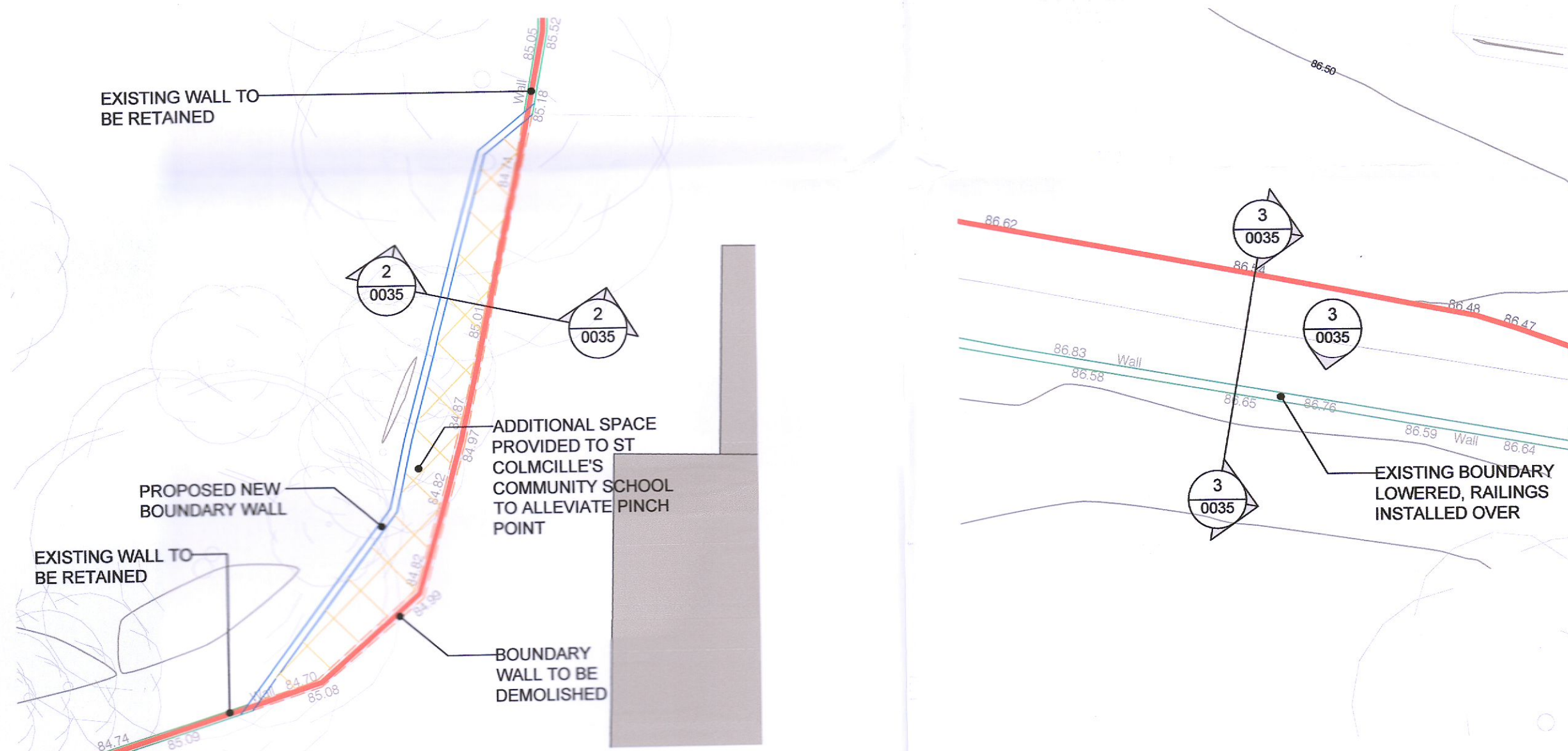


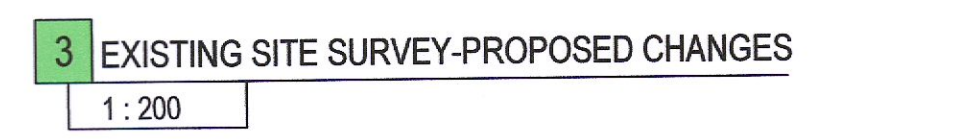

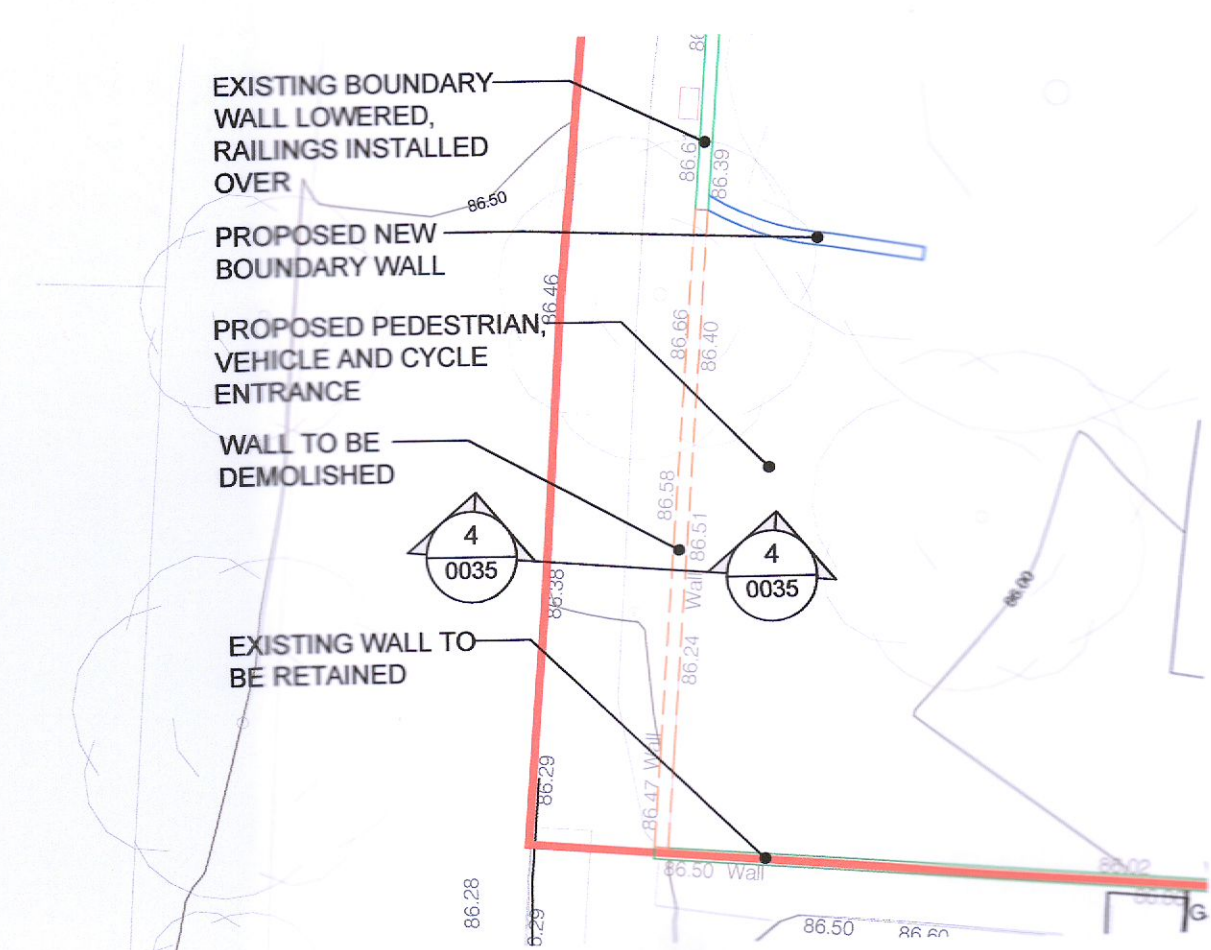
2 EXISTING SITE SURVEY-PROPOSED CHANGES

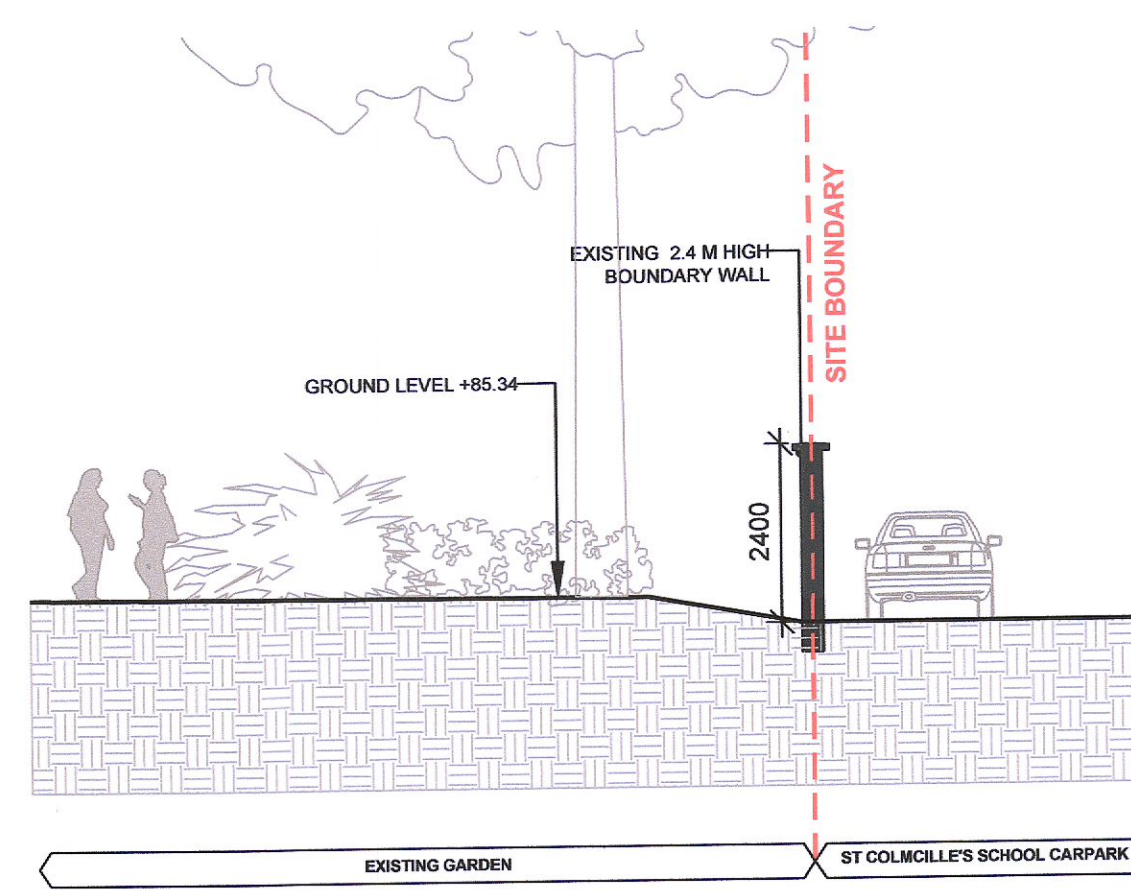

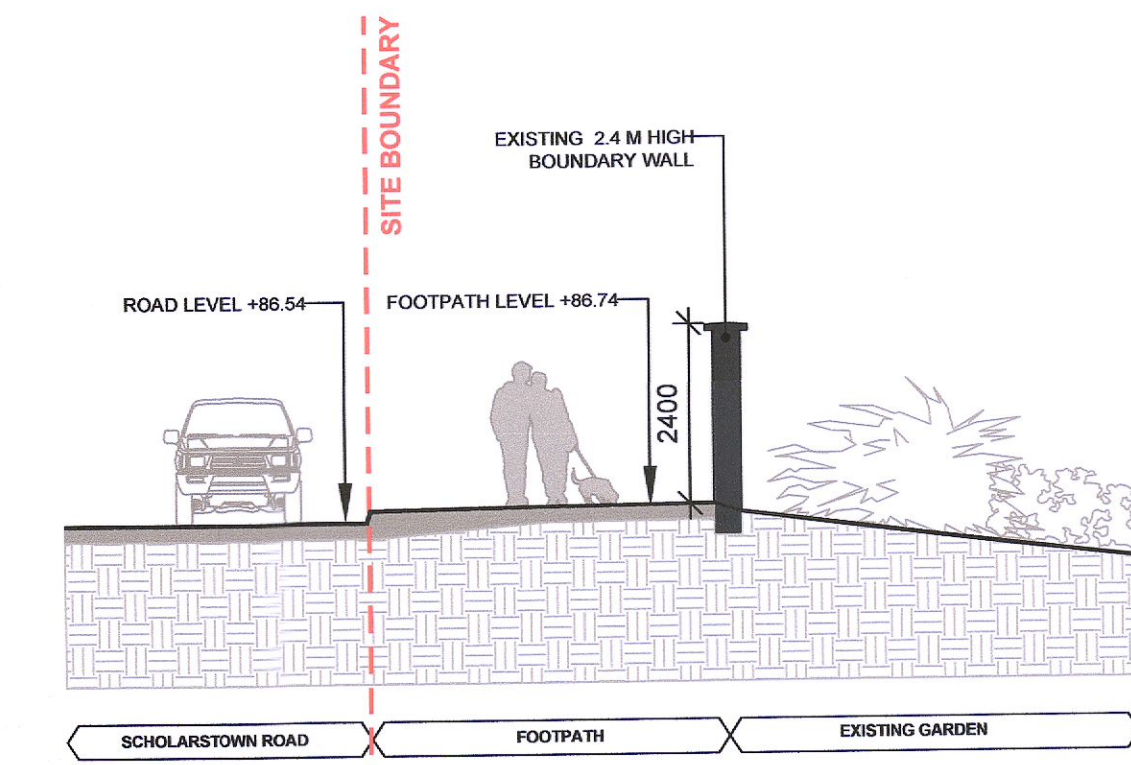

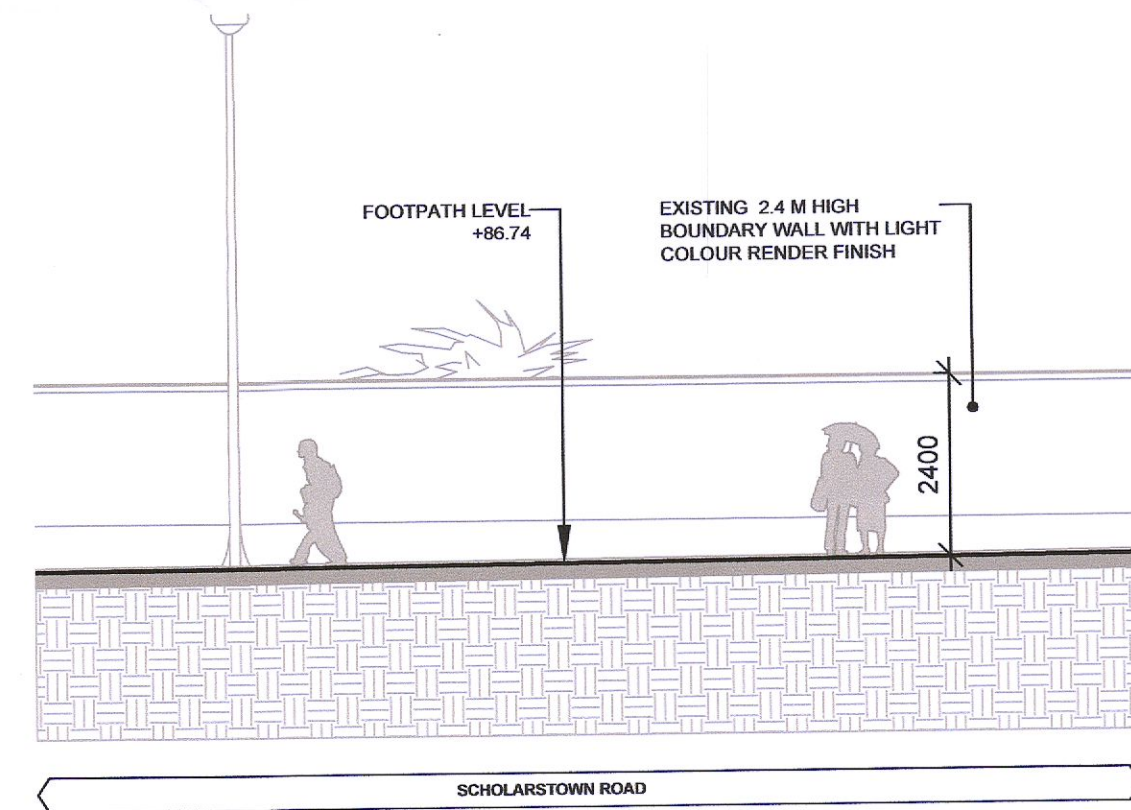

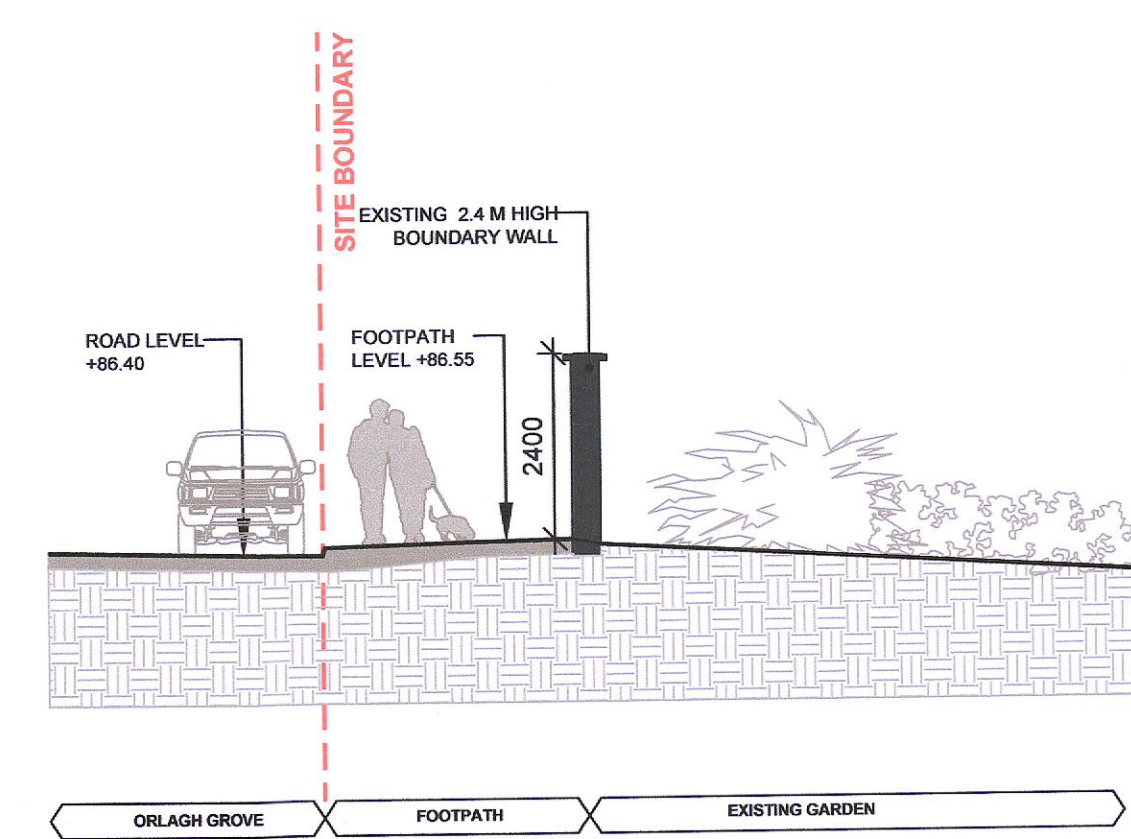

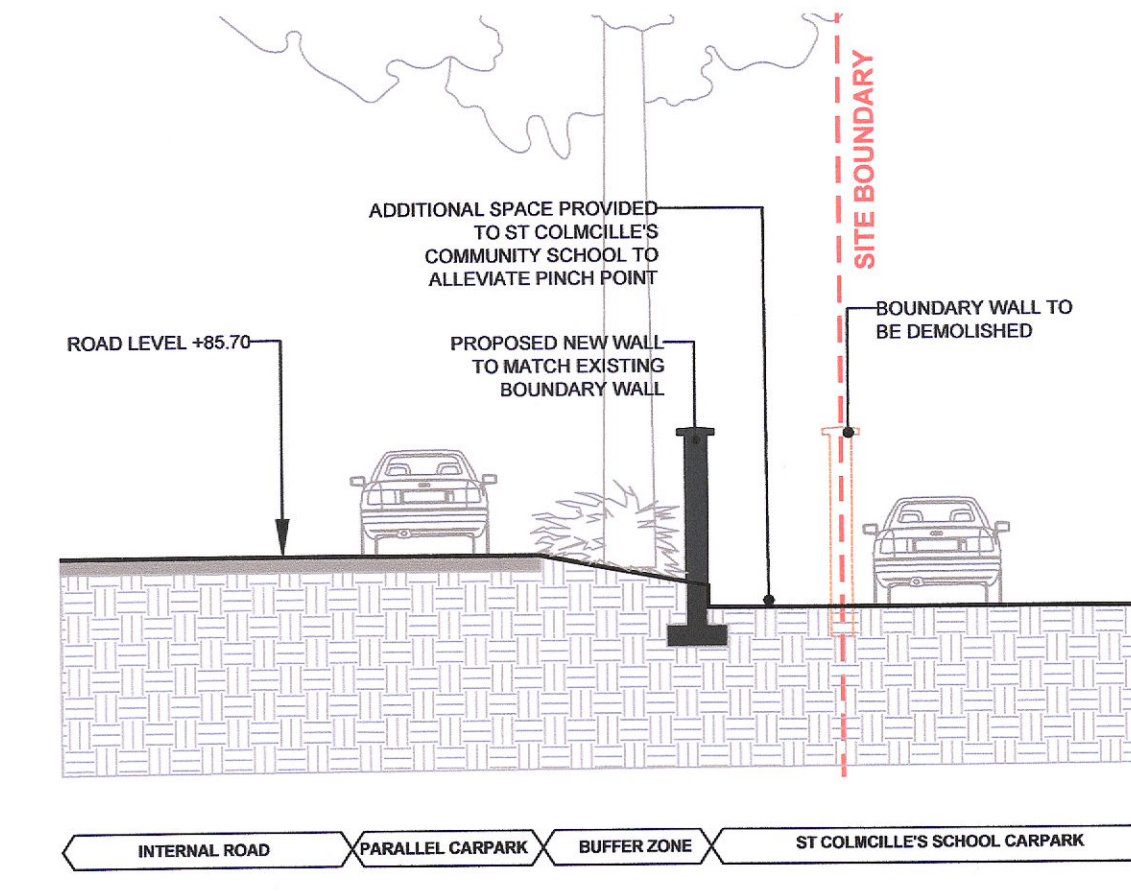
3 ELEVATION (EXISTING)

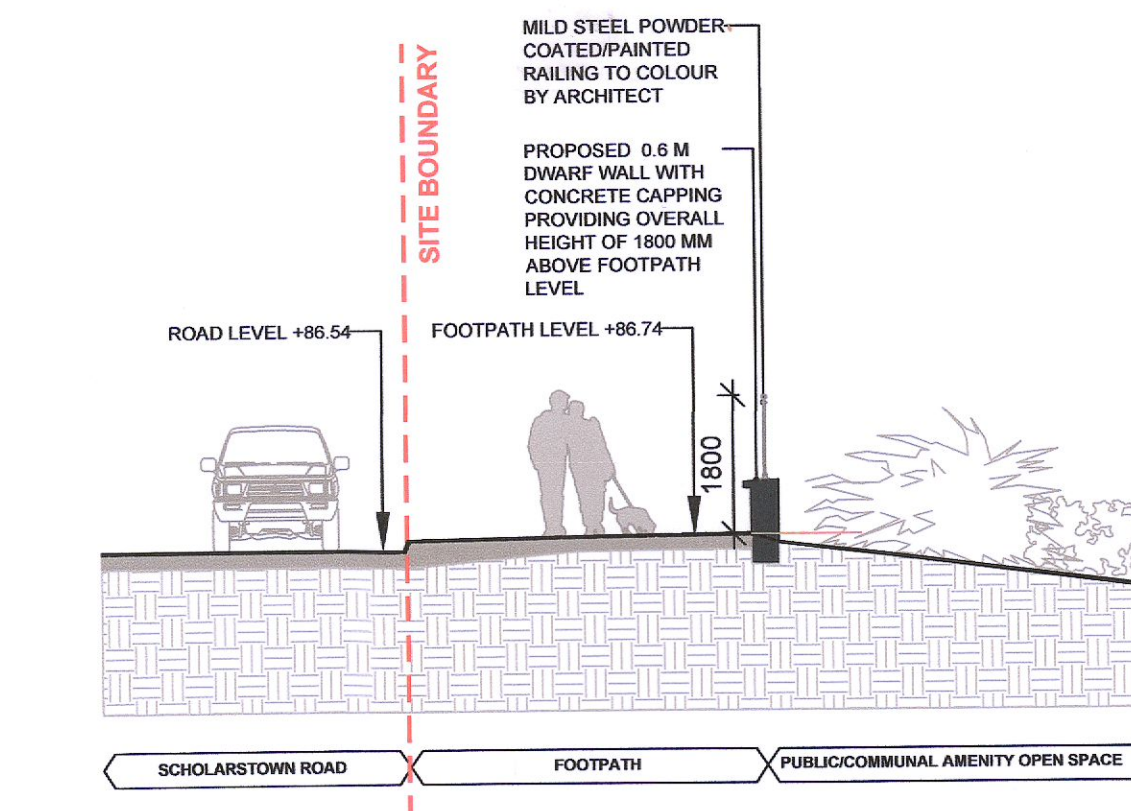

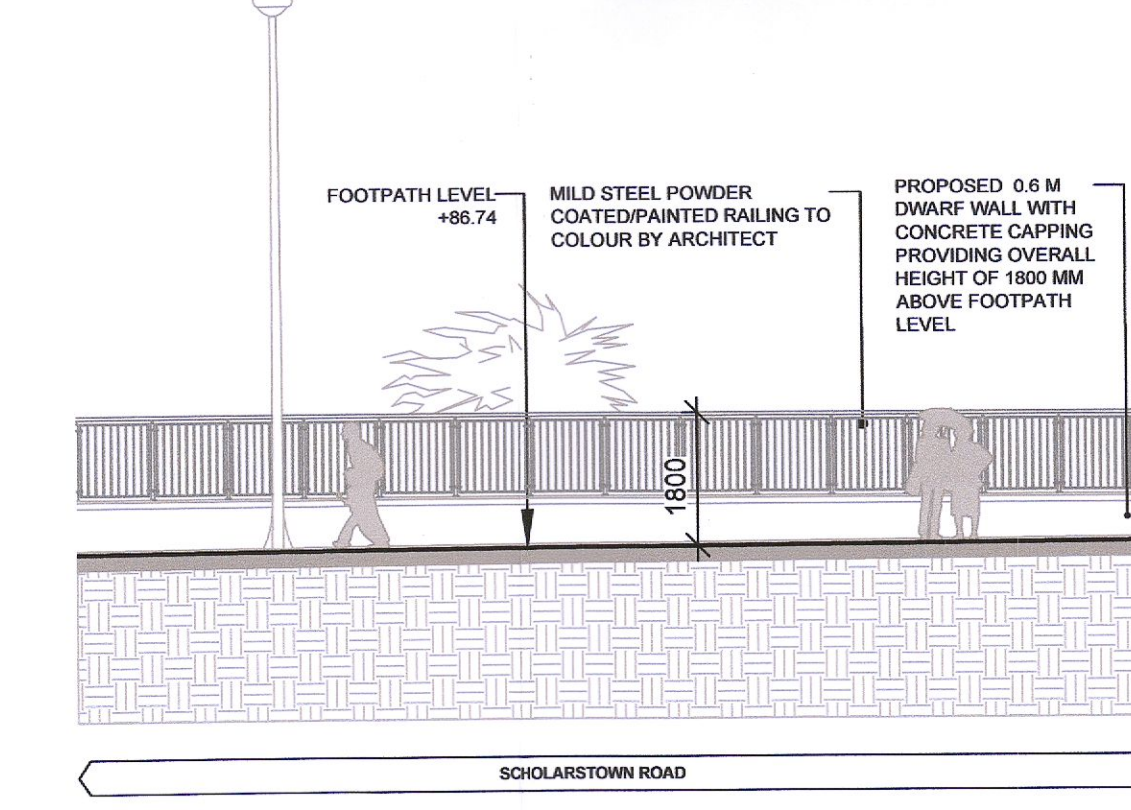

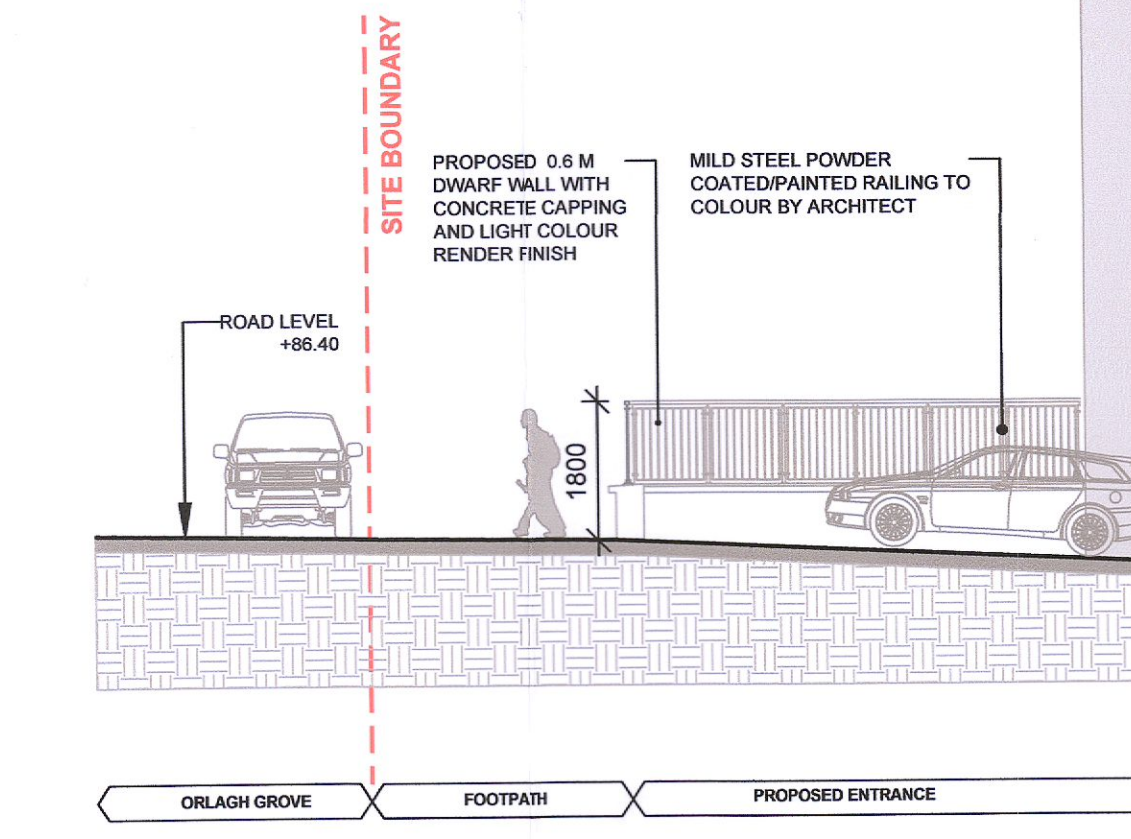
3 SECTION (PROPOSED-TYPICAL BOUNDARY WALL TREATMENT)
