The applicant is requested to provide a landscape design including additional information and detail of boundary treatment for the proposed development. The applicant shall provide a detailed landscape plan with full works specification, that accords with the specifications and requirements of the Public Realm Section. The landscape Plan shall include hard and soft landscape details, including levels, sections and elevations and detailed design of SUDs features including integrated/bio retention tree pits. The applicant is requested to provide information and additional details of proposed boundary treatment indicating the positions, design, materials and type of boundary treatments to be erected. In addition, the applicant shall also submit a landscape rationale. The landscape proposals to be prepared by a suitably qualified landscape architect.

These proposals shall include additional landscape details, SUDS measures (such as permeable paving, green roofs, filtration planting, above ground attenuation ponds etc) and planting for carbon sequestration and pollination. Response shall include drawings.

- 5. Landscape Management and Maintenance Plan The applicant is requested to submit a Landscape and Soft Works Management and Maintenance Plan for the proposed development for the approval of the Planning Authority.
- 6. Bird boxes and bat boxes/tubes The applicant is requested to provide a scheme for the erection of bird boxes and bat boxes/tubes throughout the development
- 8. The applicant is requested to clarify the relationship between landscaping proposals and the existing office development to the north. In addressing this relationship, the applicant shall clarify the exact site boundary up to the office development, clarifying who currently manages the grassed land between the indicated site boundary and the assumed boundary of the office development.
