Following a request for Further Information (Dated 08/11/2022), please find below my response to the same;

Item 1:

The Applicant is requested to provide details of the TUSLA Certification of the premises and maximum registered capacity of the existing childcare facility.

Please see attached document "Tusla Pre- Registration Regulatory Inspection Report - Inspection Due to a Proposed Change of Circumstances" (Tusla Reference: TU2015DS075), this report is a was carried out by Tusla on the 29/03/2022 to determine the suitability of the above-mentioned premises as a pre-school. As can be seen from reading the afore mentioned report Tusla have signed-off on the premises as a suitable sessional Early Years' Service, furthermore Tusla have capped the maximum number of children who are permitted to attend the existing childcare facility at 30.

c) Details of the indoor and outdoor play spaces for the subject facility of this Planning Application,

With regards to the indoor play spaces for the subject facility, the classrooms themselves are the indoor play spaces as the subject facility is a provider of the ECCE (The Early Childhood Care and Education scheme), where early education and play time interact, ECCE is provided in an informal way totally different to primary school education.

The outdoor play space is the front and rear of the building relevant to this application. The outdoor play space is shared with the adjacent "Hansel & Gretel Playschool & Afterschool" childcare service which shares the same site as the subject facility.

d) Public transport accessibility, walking and cycling routes, and car parking and drop off arrangements for staff and customers.
